# Chairman's Statement 主席報告

Dear Shareholders,

On behalf of the board (the “**Board**”) of directors (the “**Director**”), I am pleased to present to shareholders the annual report of the Company and its subsidiaries (the “**Group**”) for the year ended 30 June 2014.

The year ended 30 June 2014 has been a challenging year for the Group as we faced additional competition within the industry especially in the hospitality sector where some established environmental service providers entered the housekeeping services market.

However, the Group were able to continue to build on its success one year after our successful listing on the GEM of Stock Exchange in 2013. Our enhanced brand recognition, corporate governance and service quality enable the Group to differentiate from our competitors.

## RESULTS

During the year ended 30 June 2014, we generated revenue of approximately HK\$193.1 million, which represented a decrease of approximately 0.7% over the revenue for the year ended 30 June 2013 (2013: approximately HK\$194.5 million).

The gross profit decreased by approximately 9.4% from approximately HK\$29.8 million for the year ended 30 June 2013 to approximately HK\$27.0 million for the year ended 30 June 2014.

The net profit after tax of our Group for the year ended 30 June 2014 was approximately HK\$13.1 million, representing approximately 322.6% increase from that of previous year (2013: approximately HK\$3.1 million).

## DIVIDENDS

The Board does not recommend the payment of a final dividend for the year ended 30 June 2014 (2013: HK\$2.0 million).

各位股東：

本人謹代表董事(「**董事**」)會(「**董事會**」)欣然向股東提呈本公司及其附屬公司(「**本集團**」)截至二零一四年六月三十日止年度的年度報告。

截至二零一四年六月三十日止年度充滿挑戰，因本集團面對行業內更多競爭，尤其是在酒店業，多名雄厚環境服務供應商進入房務服務市場。

然而，在於二零一三年在聯交所創業板成功上市一年後，本集團仍能夠繼續邁向成功。經提升的品牌認可度、企業管治及服務質量使本集團能於競爭者中脫穎而出。

## 業績

於截至二零一四年六月三十日止年度，本公司錄得收益約193,100,000港元，較截至二零一三年六月三十日止年度的收益(二零一三年：約194,500,000港元)減少約0.7%。

毛利下跌約9.4%，由截至二零一三年六月三十日止年度約29,800,000港元，減至截至二零一四年六月三十日止年度約27,000,000港元。

本集團截至二零一四年六月三十日止年度的除稅後純利約為13,100,000港元，較去年(二零一三年：約3,100,000港元)增加約322.6%。

## 股息

董事會不建議派付截至二零一四年六月三十日止年度末期股息(二零一三年：2,000,000港元)。

## PROSPECTS

With the Statutory Minimum Wage (“**SWM**”) set to be reviewed in May 2015, our cost of services should inevitably increase. Nevertheless, we trust that opportunity still exists despite the market fierce competition. The trend to outsource environmental services by our customers and the increasing number of commercial and residential properties will stimulate the growth of the environmental services industry.

The Hong Kong Government's target to reduce the municipal solid waste disposal rate by 40% per capita by 2022 should enable the Group to capture this opportunity and expand our waste management and disposal and recycle services. Being one of the most comprehensive service providers in the industry, the Group shall continue to provide our view and opinion through public consultation to assist in the development of a sustainable recycling policy.

In fact, we are confident the Hong Kong Government environmental policy shall provide new business opportunities and our integrated business as well as the improving prospects in our industry shall position us well for future growth and profitability.

Subject to the prevailing market conditions and the availability of potential targets, the Group intends to explore opportunity to acquire appropriate company(ies) to strengthen our service quality and expand our service scope. As of 25 September 2014, the Group had not yet identified any definite target.

## APPRECIATION

On behalf of the Board, I would like to express my sincere gratitude to our valued customers, business partners, and shareholders for their persistent support, and express my appreciation to the management team and employees for their valuable contribution to the development of the Group. Finally, I would like to express my sincere appreciation to the officers of Stock Exchange for their guidance.

## 前景

由於將於二零一五年五月審閱法定最低工資（「**法定最低工資**」），我們的服務成本將不可避免地有所增加。雖然如此，我們相信，縱使市場競爭激烈，商機依然存在。鑒於客戶外判環境服務已成為趨勢，加上商業及住宅物業數目不斷增加，將刺激環境服務業的增長。

香港政府計劃於二零二二年前將城市固體廢棄物處置率人均減少40%，將會令本集團抓住此機會，擴大我們的廢物管理及處置以及回收服務。本集團作為行業內最全面服務供應商之一，將透過徵詢民意繼續提供我們的意見及觀點，以協助發展可持續回收利用政策。

實際上，我們相信香港政府環保政策將提供新的商機且我們的整體業務以及改善中的行業前景將使我們處於有利地位尋求未來發展及盈利。

本集團計劃物色收購合適公司的良機，以提升本公司的服務品質及拓展服務範疇，惟此受限於當時的市場情況及是否存在潛在目標。直至二零一四年九月二十五日，本集團仍未物色到任何明確目標。

## BUSINESS OVERVIEW

The Group is principally engaged in the provision of environmental services which include the provision of cleaning and related services for (i) public area and office cleaning services which involve cleaning of public areas, carpets, floors, toilets, changing rooms, lifts and escalators and emptying of garbage bins at commercial buildings, residential complexes, shopping arcades, hotels and their tenants and public transport facilities such as airport, ferries, ferry terminal, cargo and logistics centre and depots; (ii) overnight kitchen cleaning services mainly at private club and hotels; (iii) external wall and window cleaning services; (iv) stone floor maintenance and restoration services; (v) pest control and fumigation services; (vi) waste management and disposal solutions which mainly involve collection, transportation and disposal of household waste, construction waste and trade waste and sales of recyclable waste such as paper, metal and plastic waste collected during our operations; (vii) housekeeping services where we provide housekeeping services to carry out professional daily housekeeping and cleaning services at local boutique hotels, hostels and serviced apartments; (viii) secure and confidential waste destruction for commercial clients; (ix) sanitation solution for yacht; and cleaning and waste management solution for renovated apartment.

## BUSINESS REVIEW

The Group recorded stable growth in the commercial sector as we were successful in bidding a number of new contracts. Most new commercial contracts are for the provision of cleaning and related services in the Central area where customers traditionally demands a higher service quality but also willing to pay a premium price. Some of the new commercial contracts enable the Group to provide additional tenants and one-off contracts in the tenanted area of the building on a regular and ad-hoc or one-off basis.

The Group recorded double digit growth in the transportation sector as a result of a new pest control contract for the airport in Hong Kong as well as the result of the improved operating efficiency in which we re-organized our collection routes by focusing on higher value contracts and sub-contracted lower value contracts out. During the year, the Group purchased (a 9 tonnes tail lift/tipper truck and a 24 tonnes hook lift truck) to meet the increased demand for our waste management and disposal services. Due to fierce competition in contract price and labour in the hospitality sector, the Group was not successful in renewing a number of our housekeeping services contracts. The number of rooms to which the Group provided housekeeping services decreased from 950 rooms to 430 rooms per month in 2013/14. We contributed the reason for the unsuccessful renewals to the increased cost of skillful room attendants. The Group was not prepared to hire causal labour which typically is lower in cost but also in service quality.

## 業務概覽

本集團的主要業務為提供環境服務，包括提供下列各項清潔及相關服務：(i) 公眾地方及辦公室清潔服務，其涉及清潔公眾地方、地氈、地板、廁所、更衣室、升降機及自動梯，以及在商業大廈、住宅屋苑、購物商場、酒店（及其租戶）及公共運輸設施（如機場、渡輪、渡輪碼頭、貨物及物流中心及車廠）等地方收集掏空垃圾箱；(ii) 通宵廚房清潔服務，有關服務主要提供予私人會所及酒店；(iii) 外牆及玻璃清潔服務；(iv) 石材地板保養及翻新服務；(v) 滅蟲及焗霧處理服務；(vi) 廢物管理及處置解決方案，其主要涉及收集、運輸及處置住戶廢物、建築廢物及商貿廢物及銷售在本公司業務過程中收集所得的可循環再用廢物，例如：廢紙、金屬及塑膠；(vii) 房務服務，我們為本地精品酒店、賓館及服務式公寓提供房務服務，每日進行專業的房務及清潔服務；(viii) 為商業客戶提供敏感及保密文件銷毀服務；(ix) 為遊艇提供衛生解決方案；及為翻新公寓提供清潔及廢物管理解決方案。

## 業務回顧

由於我們成功競得若干新合約，本集團於商業領域錄得穩定增長。大部分新商業合約為於中環地區提供清潔及相關服務，在該地區，客戶不但一般要求優質服務，而且亦願意支付高昂的價格。個別新商業合約令本集團按經常及特別或一次性基準在大廈租戶場所提供額外租戶及一次性合約。

由於香港機場的新滅蟲合約以及由於透過專注於高價值合約及分包出低價值合約而重新組織收集路線，使經營效率提高，本集團於運輸領域錄得兩位數的增長。於本年度，本集團增購了一輛9噸尾板拈斗車及一輛24噸鈎斗卡車，以滿足廢物管理及處置服務不斷增加的需求。由於合約價格及酒店業用工競爭激烈，本集團並未成功續若干房務服務合約。於二零一三／一四年，本集團提供房務服務的房間數目由每月950間減少至430間。我們將原因歸咎於未能成功彌補資深房務員不斷增長的員工成本。本集團並未準備僱用一旦一般成本較低以及服務質量較差的臨時



# Management Discussion and Analysis 管理層討論及分析

Looking forward, we believe the fierce competition should continue in the hospitality sector, especially for the demand of skillful room attendants. In order to build up our labour force and group of room attendants, the Group shall conduct additional training classes in our training centers in Chai Wan. Our self trained room attendants can ensure the Group to control our service quality.

Revenue from other sector mainly from individual shops/offices, club houses and institutional buildings increased by double digit in 2013/14. Most of the revenue from other sector is recurring and service price is reviewable on an annual basis.

## Revenue by Service Sector

The following table sets forth the breakdown of our revenue by different sectors which reflect the target clients of our environmental services:

## Service Contracts

Contractor contracts are service contracts entered into mainly with property management companies, owners of various building premises, operators of hotels and public transportation facilities as well as government and academic institutions and are awarded to us through competitive tendering. Our major service contracts cover services provided to some designated sectors which include: (a) commercial sector which includes mainly office buildings, shopping arcades and the tenanted areas therein; (b) hospitality sector which includes hotels, hostel and serviced apartments; (c) residential sector which includes residential complexes and residential floors therein; (d) transportation sector which includes public transportations and (e) other sector which includes government and academic institutions and private clubs.

勞工。展望未來，我們相信，酒店業激烈的競爭將繼續，尤其是對資深房務員的需求。為了建立我們的勞動力及房務員團隊，本集團將於柴灣培訓中心開展額外培訓課程。我們的自培房務員可確保本集團的服務質量。

於二零一三／一四年，來自其他行業的收益主要來自個別商鋪／辦公室、會所及機關大廈以雙位數增長。大部分來自其他行業的收益為經常性及服務價格按年度基準審閱。

## 按服務分部劃分的收益

下表載列按不同行業（其反映環境服務的目標客戶）劃分的收益細明分析：

## 服務合約

承包商合約乃主要與物業管理公司、各物業擁有人、酒店及公共運輸設施營運商以及政府及學術機構訂立的服務合約，我們透過競爭投標獲授有關合約。我們的主要服務合約涵蓋向若干指定行業提供的服務，當中包括：(a) 商業界別，主要包括辦公大廈、購物商場以及當中的租戶場所；(b) 酒店業，包括酒店、旅館及服務式公寓；(c) 住宅界別，包括住宅屋苑及其中的住宅樓層；(d) 運輸界別，包括公共運輸以及(e) 其他界別，包括政府及學術機構以及私人會所。

For the year ended 30 June 2014, we had a total of 73 contracts from the abovementioned five sectors representing a decrease of approximately 12.0% from 83 contracts for the year ended 30 June 2013. Despite the decrease in number of contract on-hand, the Group was able to provide more jobs for the tenant and ad hoc cleaning service in the commercial and residential sector for the year ended 30 June 2014.

## OUTLOOK

Looking forward, we would focus our resources in high margin customers who are prepared to pay premium price for higher service quality. We would continue to strengthen our waste management and disposal services by upgrading our waste collection fleet. To lower the cost of room attendants for the hospitality sector, we shall conduct additional training and seminars. Our improvement in the commercial sector should allow the Group to build up reference for the provision of environmental services for the premium commercial buildings.

Competition for labour shall intensify due to the expected adjustment of the SMW in May 2015. From our experience, a higher SMW shall draw labour from the environmental services industry to other industries such as security service. To offset the increase in labour cost, the Group shall transfer most of the added cost to our customers.

Looking forward, the Group sees potential for the demand of environmental services in the yacht and renovated apartment. We would strengthen our marketing effort in hope to expand our market shares in these sectors. We would also continue to consolidate our resources to focus on high value customers to bring in additional revenue by cross-selling other cleaning and waste management services to our existing customers. We believe this strategy may not only improve our revenue per customer but also increase our profit margin as we could leverage our existing manpower to perform services at location where we already have presence.

於截至二零一四年六月三十日止年度，我們來自上述五個行業的合約共有73份，較截至二零一三年六月三十日止年度的83份下跌約12.0%。儘管手頭合約的數目減少，本集團於截至二零一四年六月三十日止年度仍能夠向商住領域提供更多租戶及特別服務工作機會。

## 展望

展望未來，我們將集中資源於願意為較高服務質量支付高昂價格的高利潤客戶。我們將升級我們的廢物收集車隊，繼續加強廢物管理及處置服務。為了降低酒店業房務員的成本，我們將開展額外培訓及舉行研討會。我們於商業領域的改善將令本集團為高端商業大廈確立提供環境服務的範例。

由於預期於二零一五年五月對法定最低工資作出調整，勞工競爭將趨激烈。根據我們的經驗，較高的法定最低工資將把勞動力從環境服務業引向其他行業，例如保安服務。為了抵銷增加的勞動成本，本集團將轉嫁大部份增加的成本予我們的客戶。

展望未來，本集團意識到遊艇及翻新公寓環境服務需求存在潛力。我們將增強營銷能力，藉此擴大該等領域的市場份額。我們亦將透過向我們現有客戶交叉銷售其他清潔及廢物管理服務，繼續整合資源以專注高價值客戶，以此帶來額外收益。我們相信，此策略將不僅提高我們來自每位客戶的收益，而且將提高我們的利潤率，因為我們可發揮現有人力優勢於我們已駐足的地方開展服務。

## FINANCIAL REVIEW

### Revenue

For the year ended 30 June 2014, the Group reported a revenue of approximately HK\$193.1 million (2013: approximately HK\$194.5 million), representing a decrease of approximately 0.7% as compared with that for the previous year. The net decrease was attributable to (1) a decrease in revenue from hospitality income of approximately HK\$12.9 million; (2) an increase in revenue from transportation income of approximately HK\$3.8 million; (3) an increase in revenue from residential income of approximately HK\$3.1 million; (4) an increase in revenue from commercial income of approximately HK\$2.4 million and (5) an increase in revenue from other income of approximately HK\$2.1 million.

### Cost of services

The Group's cost of services slightly increased by approximately 0.9% to approximately HK\$166.1 million (2013: approximately HK\$164.7 million) for the year ended 30 June 2014 as compared with that for the previous year. The increase in cost of services was mainly due to: (1) increase in running costs of our car fleet and (2) increase in sub-contractor fee as more sub-contractors were employed, partially offset by decrease in direct labour costs as less site staffs were employed.

### Gross profit

The gross profit of the Group for the year ended 30 June 2014 decreased by approximately 9.4% to approximately HK\$27.0 million (2013: approximately HK\$29.8 million) as compared with that for the previous year. The gross profit margin of the Group decreased to approximately 14.0% for the year ended 30 June 2014 (2013: approximately 15.3%). The decrease in gross profit was mainly due to decrease in revenue and increase in cost of services as mentioned in above.

### Other income and gains

The Group's other income and gains for the year ended 30 June 2014 increased by approximately 522.2% to approximately HK\$5.6 million (2013: approximately HK\$0.9 million) as compared with that for the previous year. The increase was mainly attributable to the reversal of provision for long service payments, severance payments, untaken paid leave, staff allowances and bonus, and claims for the year ended 30 June 2014.

## 財務回顧

### 收益

於截至二零一四年六月三十日止年度，本集團錄得收益約193,100,000港元(二零一三年：約194,500,000港元)，較去年減少約0.7%。淨減少主要由於(1)來自酒店業收入的收益減少約12,900,000港元；(2)來自運輸收入的收益增加約3,800,000港元；(3)來自住宅收入的收益增加約3,100,000港元；(4)來自商業收入的收益增加約2,400,000港元及(5)來自其他收入的收益增加約2,100,000港元。

### 服務成本

於截至二零一四年六月三十日止年度，本集團的服務成本較去年略微增加約0.9%，增至約166,100,000港元(二零一三年：約164,700,000港元)。服務成本增加主要由於：(1)車隊的日常開支增加及(2)因僱用更多分包商令分包費用增加並被僱用更少現場員工導致直接勞動成本減少所部分抵銷。

### 毛利

於截至二零一四年六月三十日止年度，本集團的毛利較去年下跌約9.4%，減至約27,000,000港元(二零一三年：約29,800,000港元)。於截至二零一四年六月三十日止年度，本集團的邊際毛利率下跌至約14.0%(二零一三年：約15.3%)。毛利下跌主要由於上述收益下降及服務成本增加所致。

### 其他收入及收益

於截至二零一四年六月三十日止年度，本集團的其他收入及收益較去年增加約522.2%，增至約5,600,000港元(二零一三年：約900,000港元)。增加主要由於截至二零一四年六月三十日止年度長期服務金、遣散費、未提取有薪假期、員工津貼及獎金及索償之撥備撥回。

## Administrative expenses

The Group's administrative expenses for the year ended 30 June 2014 increased by approximately 6.3% to approximately HK\$15.2 million (2013: approximately HK\$14.3 million) as compared with that for the previous year. The administrative expenses mainly consisted of auditors' remuneration, legal and professional fees, staff costs (including Directors' remuneration), depreciation expenses and rental expenses. The increase in the administrative expenses was mainly attributable to increase in Directors' remuneration and professional fee during the year ended 30 June 2014.

## Finance costs

The Group's finance costs for the year ended 30 June 2014 decreased to approximately HK\$0.4 million (2013: approximately HK\$0.6 million). The decrease was mainly attributable to the decrease in incurrence of interest expenses on the car finance.

## Net profit

The Group recorded a net profit attributable to owners of the Company for the year ended 30 June 2014 increased by 322.6% to approximately HK\$13.1 million (2013: approximately HK\$3.1 million) as compared with that for the previous year. The increase in net profit was mainly resulted from the recognition of one-off listing expenses amounted to approximately HK\$9.7 million for the year ended 30 June 2013. If without the listing expenses, the Group should have achieved a net profit attributable to owners of the Company of approximately HK\$12.8 million for the year ended 30 June 2013, which is stable when compared with that for year ended 30 June 2014.

## Earnings per share

The basic earnings per share for the year ended 30 June 2014 was approximately HK1.31 cents (2013: approximately HK0.41 cents (restated)). Diluted earnings per share was the same as the basic earnings per share for the years ended 30 June 2014 and 2013 as the Group had no dilutive potential ordinary shares in issue during these years.

## USE OF PROCEEDS

During the period from 17 June 2013 to 30 June 2014, the net proceeds from the Placing had been applied as follows:

於截至二零一四年六月三十日止年度，本集團錄得本公司擁有人應佔純利約13,100,000港元(二零一三年：約3,100,000港元)，較去年上升約322.6%。純利增加主要由於在截至二零一三年六月三十日止年度確認一次性上市開支約9,700,000港元所致。倘沒有上市開支，則截至二零一三年六月三十日止年度本集團應錄得本公司擁有人應佔純利約12,800,000港元，與截至二零一四年六月三十日止年度持平。

## 每股盈利

截至二零一四年六月三十日止年度的每股基本盈利約為1.31港仙(二零一三年：約0.41港仙)(經重列))。由於本集團於截至二零一四年及二零一三年六月三十日止年度並無已發行潛在攤薄普通股，因此，於該等年度每股攤薄盈利與每股基本盈利相同。

The Group is taking a strategic move to further utilize its competitive edge in the waste management service by acquiring two specialized vehicles of a 9 tonnes tail lift/tipper truck and a 24 tonnes hook lift truck. The 9 tonnes tail lift/tipper truck is deployed to collect recyclable items such as paper, metal and plastic waste collected during our operations for resale and the 24 tonnes hook lift truck is deployed for the operation at one of the major convention and exhibition venues in Hong Kong after the Group successfully renewed its contract.  
  
To better maintain the operation cost of our waste management service, the Group is in the process of hiring an additional fleet supervisor who can also perform minor maintenance to our vehicles.
  2. The Group has expanded our advertisements by engaging a leading online search engine company to promote the Group's cleaning and waste management services. Regular advertising and marketing campaigns were carried out through the use of direct mail and distribution of leaflet and brochure. The Group has upgraded to a new email and file server to enhance our operational efficiency. We have hired an additional contracting staff to promote our services and renew our service quotation in order to enhance our profit margin. Finally, a senior operation manager was hired to improve our operation efficiency and service quality by providing additional internal training and product knowledge to our front line staff.
  3. The Group has hired an additional 20 room attendants for our housekeeping operations. As the competition for housekeeping market increases, the Group shall focus on bringing in higher margin contracts rather than focusing on increasing the number of rooms served.
  4. The Group has started to promote its secure and confidential waste destruction services to our existing commercial clients. We believe by leveraging our relationship with existing customers, it may allow us to build up a client base with lower administration and marketing costs.

  4. 本集團已著手向現有商業客戶推廣旗下敏感及保密文件銷毀服務。我們相信，憑藉我們與現有客戶已建立的關係，可讓我們得以較低的行政及市場推廣成本建立客戶基礎。

## Capital Structure

The Shares were listed on GEM on 17 June 2013. The share capital of the Group comprises only ordinary shares. The capital structure of the Group mainly consists of bank borrowing and obligations under finance leases; and equity attributable to owners of the Group, comprising issued share capital and retained earnings respectively.

The Directors of the Company review the capital structure regularly, taking into account the cost of capital and the risks associated with the capital. The Group considers the cost of capital and the risks associated with each class of capital to monitor its capital structure on the basis of a gearing ratio. This ratio is expressed by as a percentage of total borrowings over the total equity.

## Liquidity and Financial Resources

During the year ended 30 June 2014, the Group generally financed its operations through internally generated cash flows and net proceeds from the IPO.

As at 30 June 2014, the Group had net current assets of approximately HK\$52.9 million (30 June 2013: approximately HK\$36.8 million), including cash and cash equivalents of approximately HK\$37.4 million (30 June 2013: approximately HK\$28.5 million). The current ratio, being the ratio of current assets to current liabilities, was approximately 2.9 as at 30 June 2014 (30 June 2013: approximately 1.9) which remains healthy.

The Board considers that the Group's financial resources are sufficient for its operation. If necessary, the Board would consider either debt or equity financing, or both, for business development, especially when appropriate business opportunities are identified and market conditions are favourable.

## Gearing Ratio

The gearing ratio, which is based on the total amounts of bank borrowing and obligations under finance leases divided by total equity, was approximately 7.5% as at 30 June 2014 (30 June 2013: approximately 13.0%). The decrease was mainly resulted from decrease in obligations under finance leases and increase in equity due to increase in retained earnings for the year ended 30 June 2014.

## Foreign Exchange Exposure

The Group's foreign currency exposure is limited as most of its transactions, assets and liabilities are denominated in Hong Kong dollars.

## Employee and Remuneration Policies

The Group's remuneration policies are in line with the prevailing market practices and formulated on the basis of performance and experience of the employees. The salary and related benefits of the employees are rewarded on a performance related basis and the general remuneration structure of the Group is subject to review annually.

## 資本結構

於二零一四年六月三十日，本集團的流動資產淨值約為52,900,000港元（二零一三年六月三十日：約36,800,000港元），包括現金及現金等價物約37,400,000港元（二零一三年六月三十日：約28,500,000港元）。於二零一四年六月三十日，流動比率（即流動資產對流動負債的比率）約為2.9（二零一三年六月三十日：約1.9），仍然處於穩健水平。

董事會認為本集團的財務資源充裕，足以應付業務運作所需。如有需要，董事會會考慮進行債務融資或股本融資（或兩者同時進行）以拓展業務，特別是當物色到適當商機及市場環境利好的情況下可進行融資。

## 資產負債比率

資產負債比率乃按銀行借款總額及融資租賃承擔的總額除以權益總額計算，於二零一四年六月三十日約為7.5%（二零一三年六月三十日：約13.0%）。資產負債比率下降主要由於截至二零一四年六月三十日止年度的融資租賃承擔減少及保留盈利增加令權益增加所致。

## 外匯風險

## Capital Commitment

As at 30 June 2014, the Group did not have any significant capital commitments (30 June 2013: approximately HK\$0.04 million).

## Charges on the Group's Assets

Our decrease in obligations under finance leases from approximately HK\$6.9 million as at 30 June 2013 to approximately HK\$3.6 million as at 30 June 2014, were primarily due to lesser specialized vehicles we acquired using finance leases during the year ended 30 June 2014. As at 30 June 2014, we had obligations under finance leases of approximately HK\$3.6 million, of which approximately HK\$2.7 million was repayable within one year. Such obligations under finance leases were secured by the relevant motor vehicles.

Save as mentioned above in this section, we did not have any outstanding mortgages or charges, borrowings or indebtedness including bank overdrafts, loans or debentures, loan capital, debt securities or other similar indebtedness, finance leases or hire purchase commitments, liabilities under acceptances or acceptance credits outstanding as at 30 June 2014 that have charges on the Group's assets.

## Contingent Liabilities

As at 30 June 2014, the Group did not have any material contingent liabilities (30 June 2013: HK\$Nil).

## Information on Employees

As at 30 June 2014, the Group had 789 staffs in Hong Kong. Total staff costs and related expenses (including Directors' remuneration) for the year ended 30 June 2014 decreased by approximately 6.2% over that for the previous year. The net decrease was mainly due to more sub-contractors were employed to substitute the site-staff, off-set by increase in Directors' remuneration.

## Significant Investment Held

During the year ended 30 June 2014, the Group did not have any significant investment.

## Future Plans for Material Investments and Capital Assets

During the years ended 30 June 2014, the Group did not have other plans for material investments and capital assets.

## Material Acquisitions and Disposals of Subsidiaries and Affiliated Companies

For the year ended 30 June 2014, there were no material acquisitions or disposals of subsidiaries made by the Group.

## DIRECTORS

The Board currently consists of ten Directors comprising four executive Directors, two non-executive Directors and four independent non-executive Directors.

### Executive Directors

**Mr. Fan Shek Cheong, Allan (“Mr. Fan”)**, aged 65, was appointed a Director on 31 May 2012 and was designated as an executive Director and the Chairman of the Company on 28 May 2013. Mr. Fan has about 35 years of experience in the cleaning industry when he founded the Group with his then business partner in July 1978. Mr. Fan is primarily responsible for leading the strategic planning and business development of the Group. Together with other members of the senior management, Mr. Fan oversees all key aspects of the operations of the Group. Mr. Fan has served as the director of PPC since 1978 and PPS since 1986. Mr. Fan is the father of Ms. Maria Fan and the father-in-law of Mr. Samuel Wong.

**Mr. Cao Zhiwen (“Mr. Cao”)**, aged 40, was appointed as Director and was designated as executive Director and Vice-Chairman of the Company on 7 August 2014. Mr. Cao has approximately 17 years’ experience in business management and commercial investment. Mr. Cao used to study at the Department of Computer Science of Jiayi Normal University and completed the EMBA program of Tsinghua University. Mr. Cao is currently the chairman of the board of Shenzhen Habala Asset Management Company Limited. Mr. Cao used to be the chairman of the board of Shenzhen Xilang Science and Technology Company Limited and Shenzhen Habala Recreational Vehicle Investment and Development Company Limited.

**Mr. Wong Yin Jun, Samuel (“Mr. Wong”)**, aged 39, was appointed an executive Director on 28 May 2013. Mr. Wong oversees our contracting department and is primarily responsible for setting sales and marketing strategies for our business. Mr. Wong joined our Group in September 2009 as an assistant to general manager. He has been a director of PPS and PPC, respectively, since March 2010. Mr. Wong has around 10 years of experience in sales and marketing. He graduated from Simon Fraser University, Canada in 1998, with a Bachelor Degree in Arts and obtained a Master Degree in Business Administration from the University of San Francisco, the United States, in 2005. Mr. Wong is the son-in-law of Mr. Allan Fan and the husband of Ms. Maria Fan.

To the best knowledge, information and belief of the Directors, the Investors are independent third parties not connected with the Company and its connected persons (as defined under the GEM Listing Rules) (such disposals shall be collectively referred to as the "Disposals"). Shares disposed via the Disposals represent in aggregate approximately 28% of the total issued share capital of the Company (the "Share Capital"). Following the Disposals, the total interests of Mr. Fan in the Shares including family and other interests within the meaning of Part XV of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) are 420,000,000 Shares, representing approximately 42% of the Share Capital, of which 225,000,000 Shares, representing approximately 22.5% of the Share Capital, had been charged as security (the "Charged Shares") in favour of Mr. Fong Shing Kwong, Michael ("Mr. Fong") for a facility granted to Viva Future.

On 4 August 2014, the Company received a notice from Mr. Fan that the Charged Shares have been released by Mr. Fong and the relevant registration procedures for the release of charge of the relevant Charged Shares have been completed.

The Board hereby presents this Corporate Governance Report for the year ended 30 June 2014.

## CORPORATE GOVERNANCE PRACTICES

The Company has applied the principles and code provisions in the Corporate Governance Code and Corporate Governance Report (the "Code") as set out in Appendix 15 to the GEM Listing Rules.

In the opinion of the Board, the Company has complied with the Code for the year ended 30 June 2014, except for the deviations of Code Provisions A.2.1 and A.2.7.

## CHAIRMAN AND EXECUTIVE DIRECTORS

Under the Code provision A.2.1, the roles of chairman and managing director should be separated and should not be performed by the same individual. During the year under review, the roles of chairman and managing director of the Company were performed by the executive Director, Mr. Fan Shek Cheong, Allan. The Company considered that the combination of the roles of chairman and managing director could effectively formulate and implement the strategies of the Company. The Company considered that under the supervision of its Board and its independent non-executive Directors, a balancing mechanism existed so that the interests of the Shareholders were adequately and fairly represented. The Company considered that there was no imminent need to change the arrangement.

Under the Code provision A.2.7, the chairman of the Board should at least annually hold meetings with the non-executive Directors (including independent non-executive Directors) without the executive Directors present. During the year under review, the chairman of the Board did not hold such kind of private meetings with the non-executive Directors. The chairman of the Board considered that it was unnecessary as it would be more transparent to let the non-executive Directors speak out their views to all executive Directors in the full Board meetings which would be held at least four times a year. Besides, the chairman of the Board, being an executive Director himself, always welcomes all non-executive Directors to directly communicate with him via his email or phone to discuss any matters of the Company from time to time.

## 1. GENERAL INFORMATION

The principal place of business is located at Unit No. 503C, Block B, Sea View Estate, 2-8 Watson Road, North Point, Hong Kong.

The Company had its primary listing on the GEM of the Stock Exchange on 17 June 2013. The Company acts as an investment holding company. Details of the principal activities of its subsidiaries are set out in Note 17. In the opinion of the directors of the Company, the ultimate holding company of the Company is Viva Future Group Limited (“Viva Future”), which is incorporated in the British Virgin Islands (“BVI”). The consolidated financial statements are presented in thousands of units of Hong Kong Dollars (HK\$’000), unless otherwise stated.

HKAS 27 (as revised in 2011) is not applicable to the Group as it deals only with separate financial statements.

The impact of the application of these standards is set out below.

#### Impact of the application of HKFRS 10

HKFRS 10 replaces the parts of HKAS 27 Consolidated and Separate Financial Statements that deal with consolidated financial statements and HK(SIC) Int-12 Consolidation – Special Purpose Entities. HKFRS 10 changes the definition of control such that an investor has control over an investee when (a) it has power over the investee, (b) it is exposed, or has rights, to variable returns from its involvement with the investee and (c) has the ability to use its power to affect its returns. All three of these criteria must be met for an investor to have control over an investee. Previously, control was defined as the power to govern the financial and operating policies of an entity so as to obtain benefits from its activities. Additional guidance has been included in HKFRS 10 to explain when an investor has control over an investee. Some guidance included in HKFRS 10 that deals with whether or not an investor that owns less than 50% of the voting rights in an investee has control over the investee is relevant to the Group.

HKFRS 11 deals with how a joint arrangement of which two or more parties have joint control should be classified and accounted for. Under HKFRS 11, there are only two types of joint arrangements – joint operations and joint ventures. The classification of joint arrangements under HKFRS 11 is determined based on the rights and obligations of parties to the joint arrangements by considering the structure, the legal form of the arrangements, the contractual terms agreed by the parties to the arrangement, and, when relevant, other facts and circumstances. A joint operation is a joint arrangement whereby the parties that have joint control of the arrangement (i.e. joint operators) have rights to the assets, and obligations for the liabilities, relating to the arrangement. A joint venture is a joint arrangement whereby the parties that have joint control of the arrangement (i.e. joint venturers) have rights to the net assets of the arrangement. Previously, HKAS 31 contemplated three types of joint arrangements – jointly controlled entities, jointly controlled operations and jointly controlled assets. The classification of joint arrangements under HKAS 31 was primarily determined based on the legal form of the arrangement (e.g. a joint arrangement that was established through a separate entity was accounted for as a jointly controlled entity).

The initial and subsequent accounting of joint ventures and joint operations is different. Investments in joint ventures are accounted for using the equity method (proportionate consolidation is no longer allowed). Investments in joint operations are accounted for such that each joint operator recognises its assets (including its share of any assets jointly held), its liabilities (including its share of any liabilities incurred jointly), its revenue (including its share of revenue from the sale of the output by the joint operation) and its expenses (including its share of any expenses incurred jointly). Each joint operator accounts for the assets and liabilities, as well as revenues and expenses, relating to its interest in the joint operation in accordance with the applicable standards.

#### Impact of the application of HKFRS 12

HKFRS 12 is a new disclosure standard and is applicable to entities that have interests in subsidiaries, joint arrangements, associates and/or unconsolidated structured entities. In general, the application of HKFRS 12 has resulted in more extensive disclosures in the consolidated financial statements.

The scope of HKFRS 13 is broad; the fair value measurement requirements of HKFRS 13 apply to both financial instrument items and non-financial instrument items for which other HKFRSs require or permit fair value measurements and disclosures about fair value measurements, except for share-based payment transactions that are within the scope of HKFRS 2 **Share-based Payment**, leasing transactions that are within the scope of HKAS 17 **Leases**, and measurements that have some similarities to fair value but are not fair value (e.g. net realisable value for the purposes of measuring inventories or value in use for impairment assessment purposes).

HKFRS 13 defines the fair value of an asset as the price that would be received to sell an asset (or paid to transfer a liability, in the case of determining the fair value of a liability) in an orderly transaction in the principal (or most advantageous) market at the measurement date under current market conditions. Fair value under HKFRS 13 is an exit price regardless of whether that price is directly observable or estimated using another valuation technique. Also, HKFRS 13 includes extensive disclosure requirements.

HKFRS 13 requires prospective application from 1 January 2013. In addition, specific transitional provisions were given to entities such that they need not apply the disclosure requirements set out in the standard in comparative information provided for periods before the initial application of the standard. In accordance with these transitional provisions, the Group has not made any new disclosures required by HKFRS 13 for the 2013 comparative period. Other than the additional disclosures, the application of HKFRS 13 has not had any material impact on the amounts recognised in the consolidated financial statements.

## 2. APPLICATION OF NEW AND REVISED HONG KONG FINANCIAL REPORTING STANDARDS (“HKFRSs”) (CONTINUED)

### HKFRS 9 Financial Instruments

HKFRS 9 issued in 2009 introduced new requirements for the classification and measurement of financial assets. HKFRS 9 was amended in 2010 to include requirements for the classification and measurement of financial liabilities and for derecognition.

Key requirements of HKFRS 9 are described below:

- All recognised financial assets that are within the scope of HKAS 39 **Financial Instruments: Recognition and Measurement** to be subsequently measured at amortised cost or fair value. Specifically, debt investments that are held within a business model whose objective is to collect the contractual cash flows, and that have contractual cash flows that are solely payments of principal and interest on the principal outstanding are generally measured at amortised cost at the end of subsequent reporting periods. All other debt investments and equity investments are measured at their fair values at the end of subsequent accounting periods. In addition, under HKFRS 9, entities may make an irrevocable election to present subsequent changes in the fair value of an equity investment (that is not held for trading) in other comprehensive income, with only dividend income generally recognised in profit or loss.
- With regard to the measurement of financial liabilities designated as at fair value through profit or loss, HKFRS 9 requires that the amount of change in the fair value of the financial liability that is attributable to changes in the credit risk of that liability is presented in other comprehensive income, unless the recognition of the effects of changes in the liability's credit risk in other comprehensive income would create or enlarge an accounting mismatch in profit or loss. Changes in fair value of financial liabilities attributable to changes in the financial liabilities' credit risk are not subsequently reclassified to profit or loss. Previously, under HKAS 39, the entire amount of the change in the fair value of the financial liability designated as fair value through profit or loss was presented in profit or loss.

### 香港財務報告準則第9號金融工具

於二零零九年頒佈之香港財務報告準則第9號引入有關金融資產分類及計量之新規定。於二零一零年修訂之香港財務報告準則第9號包括對金融負債分類及計量與取消確認之規定。

- 屬香港會計準則第39號金融工具：確認及計量範圍內之所有已確認金融資產其後均須按攤銷成本或公平值計量。特別是，旨在收取訂約現金流之業務模式，以及純粹為支付本金額及尚未償還本金之利息而擁有之訂約現金流之債務投資，一般於其後會計期間結束時按攤銷成本計量。所有其他債務投資及股本投資則於其後報告期間按公平值計量。此外，根據香港財務報告準則第9號，實體可以不可撤回地選擇於其他全面收益呈列股本投資(並非持作買賣)之其後公平值變動，而一般僅於損益內確認股息收入。
- 就按公平值計入損益之金融負債之計量而言，香港財務報告準則第9號規定，除非於其他全面收益確認該負債信貸風險變動之影響，會產生或增加損益之會計錯配，否則，因負債之信貸風險改變而導致金融負債公平值金額的變動乃於其他全面收益呈列。因金融負債之信貸風險而導致其公平值變動其後不會重新分類至損益。根據香港會計準則第39號，先前指定為按公平值計入損益之金融負債之全部公平值變動款額均於損益中確認。

### HKFRS 9 Financial Instruments (continued)

The directors anticipate that the application of HKFRS 9 in the future may have a significant impact on the amounts reported in respect of the Group’s financial assets and financial liabilities (e.g. the Group’s available-for-sale investments may have to be measured at fair value at the end of subsequent reporting periods, with changes in the fair value being recognised in profit or loss). Regarding the Group’s financial assets, it is not practicable to provide a reasonable estimate of that effect until a detailed review has been completed.

### Amendments to HKFRS 7 and HKAS 32 Offsetting Financial Assets and Financial Liabilities and the related disclosures

The amendments to HKAS 32 clarify existing application issues relating to the offset of financial assets and financial liabilities requirements. Specifically, the amendments clarify the meaning of “currently has a legally enforceable right of set-off” and “simultaneous realisation and settlement”.

The amendments to HKFRS 7 require entities to disclose information about rights of offset and related arrangements (such as collateral posting requirements) for financial instruments under an enforceable master netting agreement or similar arrangement.

The amendments to HKFRS 7 are effective for annual periods beginning on or after 1 January 2013 and interim periods within those annual periods. The disclosures should be provided retrospectively for all comparative periods. However, the amendments to HKAS 32 are not effective until annual periods beginning on or after 1 January 2014, with retrospective application required.

The directors anticipate that the application of these amendments to HKAS 32 and HKFRS 7 may result in more disclosures being made with regard to offsetting financial assets and financial liabilities in the future.

董事預期，日後採納香港財務報告準則第9號可能會對就本集團的金融資產及金融負債(例如，本集團的可供出售投資或會於其後報告期間按公平值計量，而公平值變動於損益中確認)所呈報的數額構成重大影響。在詳細審閱完成前就本集團的金融資產提供有關影響的合理估計並不可行。

### 香港財務報告準則第7號及香港會計準則第32號(修訂本)－抵銷金融資產與金融負債及相關披露

香港會計準則第32號(修訂本)澄清與抵銷金融資產及金融負債規定有關的現有應用問題。具體而言，此等修訂澄清「現時擁有於法律上可強制執行的抵銷權」及「同時變現及結算」的涵義。

香港財務報告準則第7號(修訂本)規定實體，披露有關金融工具在可強制執行的淨額結算總協議或類似安排享有的與抵銷權及相關安排(如抵押品過賬規定)的有關資料。

香港財務報告準則第7號(修訂本)於二零一三年一月一日或之後開始的年度期間以及該等年度期間內的中期期間生效，亦須就所有比較期間作出追溯披露。然而，香港會計準則第32號(修訂本)於二零一四年一月一日或之後開始的年度期間方始生效，並須追溯應用。

董事預期應用香港會計準則第32號及香港財務報告準則第7號的修訂本或會導致日後就抵銷金融資產及金融負債作出更多披露。

## 2. APPLICATION OF NEW AND REVISED HONG KONG FINANCIAL REPORTING STANDARDS (“HKFRSs”) (CONTINUED)

### Amendments to HKFRS 10, HKFRS 12 and HKAS 27 (2011) Investment Entities

The investment entities amendments apply to a particular class of business that qualify as investment entities. The term ‘investment entity’ refers to an entity whose business purpose is to invest funds solely for returns from capital appreciation, investment income or both. An investment entity must also evaluate the performance of its investments on a fair value basis. Such entities could include private equity organisations, venture capital organisations, pension funds, sovereign wealth funds and other investment funds.

Under HKFRS 10, reporting entities were required to consolidate all investees that they control (i.e. all subsidiaries). Preparers and users of financial statements have suggested that consolidating the subsidiaries of investment entities does not result in useful information for investors. Rather, reporting all investments, including investments in subsidiaries, at fair value, provides the most useful and relevant information.

In response to this, the amendments provide an exception to the consolidation requirements in HKFRS 10 and require investment entities to measure particular subsidiaries at fair value through profit or loss, rather than consolidate them. The amendments also set out disclosure requirements for investment entities.

The amendments are effective from 1 January 2014 with early adoption permitted in order to allow investment entities to apply the amendments at the same time they first apply the rest of HKFRS 10.

The directors anticipate that the application of these amendments to HKFRS 10, HKFRS 12 and HKFRS 27 (2011) will have no material impact on the Group’s financial performance and positions.

### 香港財務報告準則第10號、香港財務報告準則第12號及香港會計準則第27號(二零一一年)(修訂本) – 投資實體

投資實體修訂本適用於符合資格作為投資實體的特定業務類別。「投資實體」一詞所指實體指其業務宗旨是純粹為獲得資本增值回報、投資收入或兩者兼得的實體。投資實體亦須按公平值基準評估其投資表現。該等實體可包括私募股權機構、創業投資機構、退休基金、主權財富基金及其他投資基金。

根據香港財務報告準則第10號，報告實體須將其控制的所有被投資公司(即全部附屬公司)綜合入賬。財務報表的編製者及使用者均指出，將投資實體的附屬公司綜合入賬不會得出對投資者有用的資料。相反，按公平值報告所有投資(包括於附屬公司的投資)可提供最合用且相關的資料。

有鑒於此，有關修訂本對香港財務報告準則第10號的綜合入賬規定提供了例外情況，規定投資實體按公平值透過損益計量特定附屬公司，而並非將該等附屬公司綜合入賬。有關修訂本亦載列適用於投資實體的披露規定。

有關修訂本由二零一四年一月一日起生效，可提前採納，以供投資實體在首次應用香港財務報告準則第10號的其餘規定時可同時應用有關修訂本。

董事預計應用此等香港財務報告準則第10號、香港財務報告準則第12號及香港財務報告準則第27號(二零一一年)修訂本，將不會對本集團的財務表現及狀況構成重大影響。

## 2. APPLICATION OF NEW AND REVISED HONG KONG FINANCIAL REPORTING STANDARDS (“HKFRSs”) (CONTINUED)

### Amendments to HKAS 36 Recoverable Amount Disclosure for Non-Financial Assets

The amendments to HKAS 36 are to remove certain unintended disclosure requirements which may be introduced by the consequential amendments to HKAS 36 when HKFRS 13 was issued. Furthermore, these amendments require the disclosure of additional information about the fair value measurement when the recoverable amount of impaired assets is based on fair value less costs of disposal. The amendments to HKAS 36 are effective for annual periods beginning on or after 1 January 2014. Earlier application is permitted. However, an entity may not apply those amendments in periods (including comparative periods) in which it does not also apply HKFRS 13.

The directors anticipate that the application of these amendments to HKAS 36 will have no material impact on the Group’s financial performance and positions.

### Amendments to HKAS 39 Novation of Derivatives and Continuation of Hedge Accounting

The narrow-scope amendments will allow hedge accounting to continue in a situation where a derivative, which has been designated as a hedging instrument, is novated to effect clearing with a central counterparty as a result of laws or regulation, if specific conditions are met (in this context, a novation indicates that parties to a contract agree to replace their original counterparty with a new one).

This relief has been introduced in response to legislative changes across many jurisdictions that would lead to the widespread novation of over-the-counter derivatives. These legislative changes were prompted by a G20 commitment to improve transparency and regulatory oversight of over-the-counter derivatives in an internationally consistent and non-discriminatory way.

Similar relief will be included in HKFRS 9.

### 香港會計準則第36號(修訂本)披露非金融資產的可收回金額

香港會計準則第36號(修訂本)剔除，於香港財務報告準則第13號頒佈時可能由香港會計準則第36號的後續修訂引入的若干非計劃披露規定。此外，有關修訂規定，於減值資產的可收回金額乃根據公平值減出售成本計算時，須披露公平值計量的其他資料。香港會計準則第36號(修訂本)於二零一四年一月一日或之後開始的年度期間生效，並可提早應用。然而，實體於其亦不得於並無應用香港財務報告準則第13號的期間(包括比較期間)應用有關修訂。

董事預計應用此等香港會計準則第36號修訂本將不會對本集團的財務表現及狀況構成重大影響。

### 香港會計準則第39號(修訂本)－衍生工具的更替及對沖會計法的延續

適用範圍較窄的有關修訂本於衍生工具(已指定為對沖工具)其於法例或規例而作出契約更替與中央對手方進行結算的情況下，將容許繼續使用對沖會計法，惟前提是須符合特定條件，在此情況下，更替乃指合約各訂約方同意以新對手方取代原有對手方。

此放寬措施乃為應對於多個司法管轄區可能導致場外衍生工具大量合約更替的法律變動而作出。該等法律變動乃由二十國集團承諾以國際統一及非歧視方式提高場外衍生工具的透明度及監管而成。

類似放寬措施將納入香港財務報告準則第9號。

The directors anticipate that the application of these amendments to HKAS 39 will have no material impact on the Group’s financial performance and positions.

### HK (IFRIC) – Int 21 Levies

HK (IFRIC) – Int 21 is an interpretation of HKAS 37 and addresses how an entity should account for liabilities to pay levies imposed by governments, other than income taxes, in its financial statements. The principal question raised was about when the entity should recognise a liability to pay a levy. It clarifies that the obligating event that gives rise to a liability to pay a levy is the activity described in the relevant legislation that triggers the payment of the levy. HK(IFRIC) – Int 21 is effective for annual periods beginning on or after 1 January 2014 with earlier application permitted.

## 3. SIGNIFICANT ACCOUNTING POLICIES

These consolidated financial statements have been prepared in accordance with HKFRSs, which is a collective term that includes all applicable individual HKFRSs, Hong Kong Accounting Standards (“HKASs”) and Interpretations issued by the HKICPA, and accounting principles generally accepted in Hong Kong. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the Growth Enterprise Market of The Stock Exchange of Hong Kong Limited (the “GEM Listing Rules”) and by the Hong Kong Companies Ordinance.

### 香港(國際財務報告詮釋委員會)－詮釋第21號徵稅

香港(國際財務報告詮釋委員會)－詮釋第21號是對香港會計準則第37號的詮釋，並論述實體應如何於其財務報表中說明用於支付政府所徵收稅項(所得稅除外)的負債。所提出主要問題在於實體應何時確認支付徵稅的負債。其澄清因導致支付徵稅的負債之責任事件為引致支付徵稅的相關法律所述活動。香港(國際財務報告詮釋委員會)－詮釋第21號於二零一四年一月一日或之後開始的年度期間生效，可提前應用。

The preparation of consolidated financial statements in conformity with HKFRSs requires management to make judgments, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making judgments about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimates are revised if the revision affects only that period, or in the period of revision and future periods if the revision affects both current and future periods.

Judgments made by management in the application of HKFRSs that have significant effect on the consolidated financial statements and estimates with a significant risk of material adjustments in the next year are discussed in Note 4 to the consolidated financial statements.

### Basis of preparation

The measurement basis used in the preparation of the consolidated financial statements is historical cost convention. Historical cost is generally based on the fair value of the consideration given in exchange for assets.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2, leasing transactions that are within the scope of HKAS 17, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 or value in use in HKAS 36.

根據香港財務報告準則編製綜合財務報表需要管理層作出判斷、估計及假設，從而影響會計政策之應用，以及呈報之資產及負債、收入及支出之金額。該等估計及有關假設乃根據過往經驗及管理層相信於該等情況下乃屬合理之各項其他因素為基準而作出，所得結果構成就目前未能從其他來源而得出之資產及負債之賬面值所作出估計之基準。實際數字或會有別於估計數字。

按持續基準就所作估計及相關假設作出檢討。倘會計估計數字之修訂僅會影響修訂估計數字之期間，則有關會計估計數字之修訂將於該期間內確認，或倘該項會計估計數字之修訂影響現時及未來期間，則有關會計估計數字之修訂將於修訂期間及未來期間確認。

管理層在應用香港財務報告準則時所作出並對綜合財務報表有重大影響之判斷，以及具有重有風險可能在下一年度作出重大調整之估計，乃於年報的綜合財務報表附註4中討論。

### 編制基準

用於編製綜合財務報表之計量基準為歷史成本法。歷史成本通常基於用於交換資產代價之公平值。

公平值為市場參與者於計量日期在有序交易中出售資產可能收取或轉讓負債可能支付之價格，不論該價格是否直接觀察可得或使用另一種估值方法估計。估計資產或負債之公平值時，本集團考慮了市場參與者在計量日期為該資產或負債進行定價時將會考慮的資產或負債特徵。在該等綜合財務報表中作計量及／或披露目的的公平值均在此基礎上予以確定，惟香港財務報告準則第2號範圍內之以股份為基礎付款交易、香港會計準則第17號範圍內之租賃交易及以及與公平值類似但並非公平值的計量(例如，香港會計準則第2號中的可變現淨值或香港會計準則第36號中的使用價值)除外。

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

### Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities (including structured entities) controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

此外，就財務報告而言，公平值計量根據公平值計量之輸入數據可觀察程度及輸入數據對公平值計量之整體重要性分類為第一級、第二級及第三級，載述如下：

### 編製基準

綜合財務報表包括本公司及受本公司及其附屬公司控制之實體(包括結構性實體)及之財務報表。控制權即已取得，當本公司：

- 擁有對被投資公司之權力；

- 擁有行使其權力以影響其回報之能力。

倘有關事實或情況表明上文列出之三項控制權要素中之一項或多項存在變動，則本集團會對其是否控制被投資公司進行重新評估。

When the Group has less than a majority of the voting rights of an investee, it has power over the investee when the voting rights are sufficient to give it the practical ability to direct the relevant activities of the investee unilaterally. The Group considers all relevant facts and circumstances in assessing whether or not the Group's voting rights in an investee are sufficient to give it power, including:

- the size of the Group's holding of voting rights relative to the size and dispersion of holdings of the other vote holders;
- potential voting rights held by the Group, other vote holders or other parties;
- rights arising from other contractual arrangements; and
- any additional facts and circumstances that indicate that the Group has, or does not have, the current ability to direct the relevant activities at the time that decisions need to be made, including voting patterns at previous shareholders' meetings.

Where necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with those used by other members of the Group.

All intra-group transactions, balances, income and expenses are eliminated in full on consolidation.

#### Changes in the Group's ownership interests in existing subsidiaries

Changes in the Group's ownership interests in subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's interests and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

#### 編製基準(續)

當本集團擁有被投資公司少於大多數之投票權，則於投票權足以為其提供單方面指導被投資公司相關活動之實際能力時，本集團擁有對被投資公司之權力。於評估本集團於被投資公司之投票權是否足以賦予本集團權力時，本集團會考慮所有相關事實及情況，包括：

- 相對於其他選票持有人持倉之規模及分散性而言本集團投票權持倉之規模；
- 本集團、其他選票持有人或其他各方持有的潛在投票權；
- 其他合同安排產生之權利；及
- 於需要作出決定(包括之前股東大會上之投票模式)時表明本集團當前擁有或並無擁有指導相關活動之能力之任何額外事實及情況。

如有需要，會對附屬公司的財務報表作出調整，以令其會計政策與本集團其他成員公司所用者一致。

所有集團內公司間的交易、結餘、收入及支出於綜合賬目時悉數對銷。

#### 本集團於現有附屬公司的所有權權益的變動

倘本集團於附屬公司的所有權權益變動並無導致本集團失去對有關附屬公司的控制權，則此權益變動將會以股本交易入賬。本集團的權益及非控股權益的賬面值會作出調整，以反映彼等於附屬公司的相關權益變動。經調整的非控股權益金額與已支付或已收取代價的公平值金額之間的任何差額乃直接於權益確認，並撥歸本公司擁有人。

When the Group loses control of a subsidiary, it derecognises the assets (including any goodwill) and liabilities of the subsidiary at their carrying amounts at the date when control is lost, it derecognises the carrying amount of any non-controlling interest in the former subsidiary at the date when control is lost and recognises the aggregate of the fair value of the consideration received and the fair value of any retained interest, with any resulting difference being recognised as a gain or loss in profit or loss attributable to the Group. When assets of the subsidiary are carried at revalued amounts or fair values and the related cumulative gain or loss has been recognised in other comprehensive income and accumulated in equity, the amounts previously recognised in other comprehensive income and accumulated in equity are accounted for as if the Group had directly disposed of the related assets. The fair value of any investment retained in the former subsidiary at the date when control is lost is regarded as the fair value on initial recognition for subsequent accounting under HKAS 39 **Financial Instruments: Recognition and Measurement** or, when applicable, the cost on initial recognition of any investment in an associate or a jointly controlled entity.

#### Business combinations

Acquisitions of businesses are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition related costs are generally recognised in profit or loss as incurred.

##### 本集團於現有附屬公司的所有權權益的變動 (續)

倘本集團失去一間附屬公司的控制權，則將於失去控制權當日取消按賬面值確認該附屬公司的資產(包括任何商譽)及負債，並於失去控制權當日取消確認前附屬公司任何非控股權益的賬面值，以及確認所收取代價的公平值及任何保留權益的公平值的總額，所產生的差額於損益表內確認為本集團應佔的收益或虧損。倘該附屬公司的資產按重估金額或公平值列賬，而相關累計收益或虧損已於其他全面收益內確認並累計入權益，則先前於其他全面收益確認並累計入權益的款額，將按猶如本集團已直接出售相關資產入賬。於失去控制權當日於前附屬公司保留的任何投資的公平值將根據香港會計準則第39號**金融工具：確認及計量**於其後入賬時被列作初步確認的公平值，或(如適用)於聯營公司或共同控制實體的投資的初步確認成本。

#### 業務合併

收購業務採用收購法入賬。業務合併所轉讓的代價按公平值計量，而計算方法為本集團所轉讓的資產、本集團向被收購方原擁有人產生的負債及本集團於交換被收購方的控制權發行的股本權益於收購日期的公平值總額。有關收購的成本一般於產生時在損益表中確認。

At the acquisition date, the identifiable assets acquired and the liabilities assumed are recognised at their fair value at the acquisition date, except that:

- deferred tax assets or liabilities and liabilities or assets related to employee benefit arrangements are recognised and measured in accordance with HKAS 12 Income Taxes and HKAS 19 Employee Benefits respectively;
- liabilities or equity instruments related to share-based payment transactions of the acquiree or the replacement of an acquiree's share-based payment transactions with share-based payment transactions of the Group are measured in accordance with HKFRS 2 Share-based Payment at the acquisition date; and
- assets (or disposal groups) that are classified as held for sale in accordance with HKFRS 5 Non-current Assets Held for Sale and Discontinued Operations are measured in accordance with that standard.

Goodwill is measured as the excess of the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity interest in the acquiree (if any) over the net of the acquisition-date amounts of the identifiable assets acquired and the liabilities assumed. If, after reassessment, the net of the acquisition-date amounts of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

於收購日期，所收購可識別資產及所承擔負債按其於收購日期的公平值確認，惟下列項目除外：

- 遞延稅項資產或負債及與僱員福利安排有關的負債或資產分別根據香港會計準則第12號所得稅及香港會計準則第19號僱員福利確認及計量；
- 與被收購方的股份支付交易有關或以本集團的股份支付交易取代被收購方的股份支付交易有關的負債或股本工具，於收購日期根據香港財務報告準則第2號以股份支付款項計量；及
- 根據香港財務報告準則第5號持作出售的非流動資產及已終止經營業務分類為持作出售的資產(或出售組合)根據該項準則計量。

商譽乃以所轉讓的代價、任何非控股權益於被收購方中所佔金額及收購方以往持有的被收購方股本權益公平值(如有)的總和超出所收購可識別資產及所承擔負債於收購日期的淨值的部分計量。倘經過重新評估後，所收購可識別資產及所承擔負債於收購日期的淨值超出所轉讓代價、任何非控股權益於被收購方中所佔金額及收購方以往持有的被收購方權益公平值(如有)的總和，則超出部分即時於損益表內確認為議價收購收益。

Non-controlling interests that are present ownership interests and entitle their holders to a proportionate share of the entity's net assets in the event of liquidation may be initially measured either at fair value or at the non-controlling interests' proportionate share of the recognised amounts of the acquiree's identifiable net assets. The choice of measurement basis is made on a transaction-by-transaction basis. Other types of non-controlling interests are measured at their fair value or another measurement basis required by another HKFRS.

When the consideration the Group transfers in a business combination includes assets or liabilities resulting from a contingent consideration arrangement, the contingent consideration is measured at its acquisition-date fair value and considered as part of the consideration transferred in a business combination. Changes in the fair value of the contingent consideration that qualify as measurement period adjustments are adjusted retrospectively, with the corresponding adjustments being made against goodwill or gain on bargain purchase.

Measurement period adjustments are adjustments that arise from additional information obtained during the "measurement period" (which cannot exceed one year from the acquisition date) about facts and circumstances that existed as of the acquisition date. Measurement period does not exceed one year from the acquisition date.

The subsequent accounting for changes in the fair value of the contingent consideration that do not qualify as measurement period adjustments depends on how the contingent consideration is classified. Contingent consideration that is classified as equity is not remeasured at subsequent reporting dates and its subsequent settlement is accounted for within equity. Contingent consideration that is classified as an asset or a liability is remeasured at subsequent reporting dates in accordance with HKAS 39, or HKAS 37 Provisions, Contingent Liabilities and Contingent Assets, as appropriate, with the corresponding gain or loss being recognised in profit or loss.

屬現時所有權權益且於清盤時讓持有人有權按比例分佔實體資產淨值的非控股權益，可初步按公平值或非控股權益應佔被收購方可識別資產淨值的已確認金額比例計量。計量基準視乎每項交易而作出選擇。其他類別的非控股權益乃按其公平值或另一項香港財務報告準則規定的另一基準計量。

倘本集團於業務合併中轉讓的代價包括或然代價安排產生的資產或負債，則或然代價按其收購日期公平值計量，並視為於業務合併中所轉讓代價的一部分。具備計量期間調整資格的或然代價的公平值變動會作追溯調整，並會對商譽或議價購買收益作出相應調整。

計量期間調整乃於「計量期間」(自收購日期起計不可超過一年)因取得有關於收購日期已存在事實及情況的額外資料所作出的調整。計量期間自收購日期起計不會超過一年。

並不合資格作為計量期間調整的或然代價公平值變動的其後會計處理，取決於或然代價如何分類。分類為權益的或然代價並不會於其後報告日期重新計量，而其以後的結算乃於權益內入賬。分類為資產或負債的或然代價乃根據香港會計準則第39號或香港會計準則第37號撥備、或然負債及或然資產(視何者適用)於其後報告日期重新計量，而相應收益或虧損乃於損益表內確認。

When a business combination is achieved in stages, the Group's previously held equity interest in the acquiree is remeasured to fair value at the acquisition date (i.e. the date when the Group obtains control), and the resulting gain or loss, if any, is recognised in profit or loss. Amounts arising from interests in the acquiree prior to the acquisition date that have previously been recognised in other comprehensive income are reclassified to profit or loss where such treatment would be appropriate if that interest were disposed of.

If the initial accounting for a business combination is incomplete by the end of the reporting period in which the combination occurs, the Group reports provisional amounts for the items for which the accounting is incomplete. Those provisional amounts are adjusted during the measurement period (see above), or additional assets or liabilities are recognised, to reflect new information obtained about facts and circumstances that existed as of the acquisition date that, if known, would have affected the amounts recognised at that date.

#### Merger accounting for common control combination

The consolidated financial statements incorporates the financial statement items of the combining entities or business in which the common control combination occurs as if they had been combined from the date when the combining entities or businesses first came under the control of the controlling party.

The net assets of the combining entities or business are combined using the existing book values from the controlling party's perspective. No amount is recognised with respect to goodwill or any excess of acquirer's interest in the net fair value of the acquiree's identifiable assets, liabilities and contingent liabilities over its cost at the time of common control combination, to the extent of the contribution of the controlling party's interest.

倘業務合併分階段達成，本集團以往所持的被收購方股本權益於收購日期(即本集團取得控制權當日)按公平值重新計量，所產生的盈虧(如有)在損益表中確認。倘出售於被收購方權益，則以往在其他全面收益中確認有關被收購方的權益於收購日期前產生的金額會重新分類至損益表(如此處理方法合適)。

倘業務合併的初步會計處理於合併產生的報告期末仍未完成，則本集團會就仍未完成會計處理的項目呈報暫定金額。該等暫定金額於計量期間內作出調整(見上文)，或確認額外資產或負債，以反映獲得收購日期已存在事實及情況的新資料，而倘知悉該等資料，將會影響於當日確認的金額。

#### 共同控制合併的合併會計法

綜合財務報表包括發生共同控制合併的合併實體或業務的財務報表項目，猶如自合併實體或業務首次受控制方控制當日起已合併。

合併實體或業務的資產淨值按控制方的現有賬面值合併。不會確認任何商譽金額或收購方於被收購方可識別資產、負債及或然負債公平淨值的權益超出其於共同控制合併時的成本的任何差額，並以控制方權益貢獻為限。

The consolidated statement of profit or loss and other comprehensive income include the results of each of the combining entities or business from the earliest date presented or since the date when combining entities or business first came under common control, where this is a shorter period, regardless of the date of common control combination.

Intra-group transactions, balances and unrealised gains on transactions between the combining entities or business are eliminated. Unrealised losses are eliminated but considered as an impairment indicator of the asset transferred. Accounting policies of combining entities or business have been changed where necessary to ensure consistency with the policies adopted by the Group.

Transaction costs, including professional fees, registration, cost of furnishing information to shareholders, costs or losses incurred in combining operations of the previously separate businesses, etc., incurred in relation to the common control combination that is to be accounted for by using merger accounting are recognised as an expense in the period in which they are incurred.

Certain comparative amounts in the consolidated financial statements are presented as if the entities or businesses had been combined at the beginning of the previous reporting period or when they first came under common control, whichever is shorter.

綜合損益及其他全面收益表包括自最早呈列日期起或自合併實體或業務首次受共同控制日期起(以較短期間為準, 而不論共同控制合併日期)各合併實體或業務的業績。

集團內公司間的交易、結餘及合併實體或業務間交易的未變現收益會予以對銷。未變現虧損亦會對銷, 惟會被視為屬已轉讓資產減值的跡象。合併實體或業務的會計政策已作出必要變動, 以確保與本集團所採納的會計政策一致。

採用合併會計法入賬的共同控制合併所產生的交易成本(包括專業費用、註冊費、向股東提供資訊的成本、過往個別經營業務合併所產生的成本或虧損等)於產生期間確認為開支。

### Property, plant and equipment

Property, plant and equipment are stated in the consolidated statement of financial position at cost less accumulated depreciation and any impairment losses.

The cost of an asset comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Expenditure incurred after the property, plant and equipment have been put into operation, such as repairs and maintenance and overhaul costs, is normally charged to the consolidated statement of profit or loss and other comprehensive income in the period in which it is incurred. In situations where it can be clearly demonstrated that the expenditure has resulted in an increase in the future economic benefits expected to be obtained from the use of the property, plant and equipment, the expenditure is capitalised as an additional cost of that property, plant and equipment.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The estimated useful lives for the years ended 30 June 2014 and 2013 are as follows:

Furniture and fixtures	2 to 7 years
Equipment and machinery	7 years
Motor vehicles	4 years

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

Gains or losses arising from the retirement or disposal of an item of property, plant and equipment are determined as the difference between the net disposal proceeds and the carrying amount of the item and are recognised in profit or loss on the date of retirement or disposal.

### 物業、廠房及設備

物業、廠房及設備於綜合財務狀況表按成本減累計折舊及任何減值虧損列賬。

資產成本包括購入價及將該項資產達至運作狀態及地點作擬定用途的直接應佔成本。物業、廠房及設備投入運作後產生的開支，如維修與保養及檢修成本，通常於其產生期間自綜合損益及其他全面收益表扣除。倘能清楚顯示開支能增加預期使用物業、廠房及設備所獲取的未來經濟利益，則有關開支將撥作該物業、廠房及設備的額外成本。

各項物業、廠房及設備的折舊以直線法按其估計可使用年期將其成本撇銷至剩餘價值計算。於截至二零一四年及二零一三年六月三十日止年度的估計可使用年期如下：

傢具及裝置	2至7年
設備及機器	7年
汽車	4年

倘部分物業、廠房及設備項目擁有不同的可使用年期，則該項目的成本按合理基準分配至各部分，且各部分獨立折舊。剩餘價值、可使用年期及折舊方法最少會於各財政年度末檢討及調整(倘適用)。

物業、廠房及設備項目報廢或出售所產生的收益或虧損釐定為出售所得款項淨額與該項目賬面值之間的差額，並於報廢或出售日期在損益表確認。

### Impairment of tangible assets other than goodwill

At the end of each reporting period, the Group reviews the carrying amounts of its tangible assets with finite useful lives to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss, if any.

Recoverable amount is the higher of fair value less costs to sell and value in use. When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs. When a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual cash generating units, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified.

In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

### Inventories

Inventories are stated at lower of cost and net realisable value.

Cost represents the invoiced cost of inventories. Cost is assigned to individual items on the weight-average basis. Net realisable value is the estimated selling price in the ordinary course of business, less applicable variable selling expense.

### Cash and cash equivalents

For the purposes of the consolidated statements of cash flows, cash and cash equivalents comprise cash on hand, deposits held at call with banks, cash investments with a maturity of three months or less from date of investment and bank overdrafts.

### 商譽以外的有形資產的減值

於各報告期間結算日，本集團會檢討使用年期有限的有形資產賬面值，以確定是否有任何跡象顯示該等資產已蒙受減值虧損。倘存在任何有關跡象，則會估計資產的可收回金額以確定減值虧損(如有)程度。

可收回金額為扣除銷售成本後的公平值或使用價值(以較高者為準)。倘個別資產的可收回金額不能估計，則本集團會估計該資產所屬的現金產生單位的可收回金額。當可確定合理及一貫分配基準時，公司資產亦可分配至個別現金產生單位，或另行分配至能確定合理及一貫分配基準的現金產生單位最小組別。

於評估使用價值時，估計未來現金流量採用反映目前市場對貨幣時間價值及該資產特定風險評估(並無就此調整估計未來現金流量)的稅前貼現率貼現至其現值。

### 存貨

存貨按成本或可變現淨值(以較低者為準)列賬。

成本指存貨的發票成本。成本按加權平均基準分攤至個別項目。可變現淨值為日常業務過程中的估計售價減適用可變動銷售開支。

### 現金及現金等價物

就綜合現金流量表而言，現金及現金等價物包括手頭現金、銀行活期存款、到期日自投資日期起計三個月或以內的現金投資以及銀行透支。

#### Provisions and contingent liabilities

Provisions are recognised when the Group has a present obligations (legal or constructive) as a result of a past event, it is probable that the Group will be required to settle that obligations, and a reliable estimate can be made of the amount of the obligations.

The amount recognised as a provision is the best estimate of the consideration required to settle the present obligations for the reporting period, taking into account the risks and uncertainties surrounding the obligations. When a provision is measured using the cash flows estimated to settle the present obligations, its carrying amount is the present value of those cash flows (where the effect of the time value of money is material).

Provisions shall be reviewed at the end of each reporting period and adjusted to reflect the current best estimate. If it is no longer probable that an outflow of resources embodying economic benefits will be required to settle the obligation, the provision shall be reversed.

When some or all of the economic benefits required to settle a provision are expected to be recovered from a third party, a receivable is recognised as an asset if it is virtually certain that reimbursement will be received and the amount of the receivable can be measured reliably.

When the cost of cleaning services to fulfil the obligation under the contract exceeds the revenue, a provision for onerous contracts would be made. In estimating the amount by which the cleaning cost are expected to exceed the revenue, management takes into account the cost of fulfilling the obligation under the contract and any compensation or penalties arising from failure to fulfill it, which is the lower will be recognised as the unavoidable costs.

A contingent liability is a possible obligation that arises from past events and whose existence will only be confirmed by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Group it is not probable that outflow of economic resources will be required or the amount of obligations cannot be measured reliably.

#### 撥備及或然負債

當本集團因過往事件承擔現有法定或推定責任，本集團可能須履行該責任，而該責任金額能可靠估計，則確認撥備。

已確認為撥備的金額為於報告期間因履行現有責任而須承擔代價的最佳估計，並已計及責任所附帶的風險及不明朗因素。倘撥備按履行現有責任估計所需的現金流量計量，則其賬面值為該等現金流量的現值(倘貨幣時間價值影響重大)。

撥備須於各報告期間結算日檢討，並調整以反映目前最佳估計。倘不再可能需要包含經濟利益的資源流出以清償責任，則撥備將予以撥回。

當須用於清償撥備的部分或全部經濟利益預期可自第三方收回時，則應收款項會在實際確定將獲償付且能可靠估計應收款項金額時確認為資產。

當履行清潔服務合約責任的成本超出收益，便會就有償合約作出撥備。於估計清潔成本預期超出收益的金額時，管理層會考慮履行合約責任的成本以及因未能履行責任而產生的任何賠償或罰款，較低者將確認為不可避免成本。

或然負債指因過往事件而可能產生的責任，其存在與否將僅透過發生一項或多項本集團全面控制範圍以外的未來不確定事件且在經濟資源不大可能會需要流出或責任金額不能可靠計量時確定。

A contingent liability is not recognised but is disclosed in the notes to the consolidated financial statements. When a change in the probability of an outflow occurs so that outflow is probable, it will then be recognised as a provision.

### Leasing

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership to the lessee. All other leases are classified as operating leases.

#### The Group as lessee

Assets held under finance leases are initially recognised as assets of the Group at their fair value at the inception of the lease or, if lower, at the present value of the minimum lease payments. The corresponding liability to the lessor is included in the consolidated statement of financial position as obligations under finance leases.

Lease payments are apportioned between finance expenses and reduction of the lease obligations so as to achieve a constant rate of interest on the remaining balance of the liability. Finance expenses are recognised immediately in profit or loss, unless they are directly attributable to qualifying assets, in which case they are capitalised in accordance with the Group's general policy on borrowing costs (see the accounting policy below). Contingent rentals are recognised as expenses in the periods in which they are incurred.

Operating lease payments are recognised as an expense on a straight-line basis over the lease term, except where another systematic basis is more representative of the time pattern in which economic benefits from the leased asset are consumed. Contingent rentals arising under operating leases are recognised as an expense in the period in which they are incurred.

In the event that lease incentives are received to enter into operating leases, such incentives are recognised as a liability. The aggregate benefit of incentives is recognised as a reduction of rental expense on a straight-line basis, except where another systematic basis is more representative of the time pattern in which economic benefits from the leased asset are consumed.

### 撥備及或然負債 (續)

或然負債不予確認，但會於綜合財務報表附註披露。倘經濟資源流出的可能性有變以致可能出現經濟資源流出時，則會確認為撥備。

### 租賃

倘租賃條款將絕大部分所有權風險及回報轉移至承租人，則租賃分類為融資租賃。所有其他租賃分類為經營租賃。

#### 本集團作為承租人

根據融資租賃持有的資產初步按其於租賃開始時的公平值或按最低租賃款項的現值(倘金額較低)確認為本集團的資產。出租人的相應負債計入綜合財務狀況表作為融資租賃承擔。

租賃款項於融資開支與租賃承擔減少之間分配，以就餘下負債結餘達致固定利率。除非融資開支直接歸屬於合資格資產，否則融資開支即時於損益表確認，於此情況下，有關融資開支會根據本集團有關借貸成本的一般政策(見下文會計政策)資本化。或然租金於產生期間確認為開支。

經營租賃款項於租期內按直線法確認為開支，惟另有系統基準更能代表使用所租賃資產經濟利益的時間模式則除外。經營租賃所產生的或然租金於產生期間確認為開支。

倘於訂立經營租賃時收取租賃優惠，則有關優惠確認為負債。優惠總利益以直線法確認為租金開支減少，惟另有系統基準更能代表使用所租賃資產經濟利益的時間模式則除外。

### Foreign currencies

The functional currency of the Company and its subsidiaries is HK\$. The consolidated financial statements are presented in HK\$ which is the Group's presentation currency. This is also the currency of the primary economic environment in which the Group operates. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency.

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recorded in the respective functional currency (i.e. the currency of the primary economic environment in which the entity operates) at the exchange rates prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the translation of monetary items, are recognised in profit or loss in the period in which they arise, except for exchange differences arising on a monetary item that forms part of the Group's net investment in a foreign operation, in which case, such exchange differences are recognised in other comprehensive income and will be reclassified from equity to profit or loss on disposal of the foreign operation. Exchange differences arising on the retranslation of non-monetary items carried at fair value are included in profit or loss except for differences arising on the retranslation of non-monetary items in respect of which gain and losses are recognised directly in other comprehensive income, in which cases, the exchange differences are recognised directly in other comprehensive income.

### 外幣

本公司及其附屬公司的功能貨幣為港元。綜合財務報表以港元(本集團的呈報貨幣)呈列。港元亦為本集團營運所在主要經濟環境的貨幣。本集團各實體決定其自身的功能貨幣，入賬各實體財務報表的項目使用功能貨幣計量。

於編製各個別集團實體的財務報表時，以該實體功能貨幣以外的貨幣(外幣)進行的交易按相關功能貨幣(即實體營運所在主要經濟環境的貨幣)以交易日期適用匯率入賬。於報告期間結算日，以外幣列值的貨幣項目乃按該日現行利率重新換算。以公平值列賬並以外幣列值的非貨幣項目按釐定公平值日期的適用匯率重新換算。按外幣歷史成本計量的非貨幣項目不作重新換算。

結算貨幣項目及換算貨幣項目所產生的匯兌差額於其產生期間在損益表確認，惟構成本集團海外業務投資淨額一部分的貨幣項目所產生的匯兌差額除外，於該情況下，該等匯兌差額於其他全面收益確認，並自權益重新分類至出售海外業務損益。重新換算按公平值列賬的非貨幣項目所產生的匯兌差額計入損益表，惟重新換算有關直接於其他全面收益確認為盈虧的非貨幣項目所產生的差額則除外，於該等情況下，匯兌差額直接於其他全面收益確認。

For the purpose of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. HK\$) using exchange rates prevailing at the end of the reporting period. Income and expense items are translated at the average exchange rates for the period, unless exchange rates fluctuated significantly during that period, in which case the exchange rates at the dates of the transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of foreign currency translation reserve (attributed to non-controlling interests as appropriate).

On the disposal of a foreign operation (i.e. a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation, a disposal involving loss of joint control over a jointly controlled entity that includes a foreign operation, or a disposal involving loss of significant influence over an associate that includes a foreign operation), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Group are reclassified to profit or loss.

In the case of a partial disposal that does not result in the Group losing control over a subsidiary that includes a foreign operation, the proportionate share of accumulated exchange differences are re-attributed to non-controlling interests and are not recognised in profit or loss. For all other partial disposals (i.e. partial disposal of associates or jointly controlled entities that do not result in the Group losing significant influence or joint control), the proportionate share of the accumulated exchange differences is reclassified to profit or loss.

Goodwill and fair value adjustments arising on the acquisition of a foreign operation are treated as assets and liabilities of the foreign operation and translated at the rate of exchange prevailing for the reporting period. Exchange difference arising are recognised in the foreign currency translation reserve.

就呈列綜合財務報表而言，本集團海外業務的資產及負債按報告期間結算日適用匯率換算為本集團的呈報貨幣(即港元)。收入及開支項目按期間平均匯率換算，除非期內匯率發生大幅波動，於該情況下，則使用交易日期的匯率換算。所產生匯兌差額(如有)於其他全面收益確認並累計至外幣換算儲備項下的權益(倘適用，則撥歸非控股權益)。

於出售海外業務(即出售本集團海外業務全部權益或涉及失去一間附屬公司(包括海外業務)控制權的出售及涉及失去一間共同控制實體(包括海外業務)共同控制權的出售或涉及失去對一間聯營公司(包括海外業務)的重大影響力的出售)時，就本集團擁有人應佔該業務而於權益累計的全部匯兌差額則重新分類至損益表。

倘部分出售並未導致本集團失去一間附屬公司(包括海外業務)控制權，則分佔累計匯兌差額的相應部分重新撥歸至非控股權益，而不會於損益表確認。就所有其他部分出售(即部分出售聯營公司或共同控制實體而不會導致本集團失去重大影響力或共同控制權)而言，則分佔累計匯兌差額的相應部分重新分類至損益表。

收購海外業務所產生的商譽及公平值調整被視為海外業務的資產及負債，並按於報告期間的現行匯率換算。所產生的匯兌差額於外匯換算儲備確認。

### Share option expenses

The Company operates a share option scheme for the purpose to attract, retain and reward the eligible persons and to provide the eligible persons an incentive or reward for their contribution to the Group.

For grants of share options that are conditional upon satisfying specified vesting conditions, the fair value of services received is determined by reference to the fair value of share options granted at the grant date and is expensed on a straight-line basis over the vesting period, with a corresponding increase in equity (share options reserve).

At the end of the reporting period, the Company revises its estimates of the number of options that are expected to ultimately vest. The impact of the revision of the original estimates, if any, is recognised in profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to share options reserve.

For share options that vest immediately at the date of grant, the fair value of the share options granted is expensed immediately to profit or loss. When share options are exercised, the amount previously recognised in share options reserve will be transferred to share premium. When share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share options reserve will be transferred to retained earnings.

### Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

All borrowing costs are recognised in profit or loss in the period in which they are incurred.

### 購股權開支

本公司推行一項購股權計劃，旨在吸引、留聘及獎勵合資格人士，以及向曾對本集團作出貢獻的合資格人士提供獎勵或獎賞。

就須達成特定歸屬條件後方予授出的購股權而言，已收服務公平值乃經參考所授購股權於授出日期的公平值釐定，並於歸屬期間按直線法支銷，而權益(購股權儲備)將會相應增加。

於報告期間結算日，本集團會修訂其對預期最終歸屬的購股權的估計數字。修訂原有估計數字的任何影響(如有)，會於損益表確認，使累計開支反映該修訂估計數字，並於購股權儲備作相應調整。

就於授出日期即時歸屬的購股權而言，所授出購股權的公平值會即時於損益表支銷。當購股權獲行使時，先前於購股權儲備中確認的金額將轉移至股份溢價。當購股權於歸屬日期後失效或於屆滿日期仍未獲行使，先前於購股權儲備中確認的金額將轉移至保留盈利。

### 借貸成本

收購、建造或生產合資格資產(需大量時間方能達致可供擬定用途或出售的資產)直接應佔的借貸成本，會加入該等資產的成本，直至該等資產大致可供擬定用途或出售為止。

全部借貸成本於產生期間在損益表確認。

### Financial instruments

Financial assets and financial liabilities are recognised when a group entity becomes a party to the contractual provisions of the instrument. Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition.

Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in profit or loss.

### Financial assets

The Group's financial assets are trade receivables, deposits and other receivables, restricted bank deposits, fixed deposits and cash and cash equivalents which fall within the category of loan and receivables. The accounting policies adopted are set out below.

### Effective interest method

The effective interest method is a method of calculating the amortised cost of a debt instrument and of allocating interest income over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts (including all fees on points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the debt instrument, or, where appropriate, a shorter period to the net carrying amount on initial recognition.

Income is recognised on an effective interest basis for debt instruments other than those financial assets designated as at financial assets at fair value through profit or loss.

當一個集團實體成為工具合約條文的訂約方時，便會確認金融資產及金融負債。金融資產及金融負債初步按公平值計量。收購或發行金融資產及金融負債(不包括按公平值計入損益的金融資產及金融負債)直接應佔的交易成本，於初步確認時在金融資產或金融負債(視何者適用)公平值計入或扣除。

收購按公平值計入損益的金融資產或金融負債直接應佔的交易成本即時於損益表確認。

### 金融資產

##### Loan and receivables

Loan and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. Loan and receivables (including trade receivables, deposits and other receivables, restricted bank deposits, fixed deposits and cash and cash equivalents) are carried at amortised cost using the effective interest method, less any impairment.

Interest income is recognised by applying the effective interest rate, except for short-term receivables when the recognition of interest would be immaterial.

##### Impairment of financial assets

Financial assets, other than those at financial assets at fair value through profit or loss, are assessed for indicators of impairment at the end of each reporting period. Financial assets are impaired where there is objective evidence that, as a result of one or more events that occurred after the initial recognition of the financial asset, the estimated future cash flows of the financial assets have been impacted.

The objective evidence of impairment could include:

- (a) significant financial difficulty of the issuer or counterparty; or
- (b) breach of contract, such as default or delinquency in interest or principal payments; or
- (c) it becoming probable that the borrower will enter bankruptcy or financial re-organisation; or
- (d) the disappearance of an active market for that financial asset because of financial difficulties.

##### 貸款及應收款項

貸款及應收款項為具有固定或可確定付款且並無在活躍市場報價的非衍生金融資產。貸款及應收款項(包括貿易應收款項、按金及其他應收款項、受限制銀行存款、定期存款及現金及現金等價物)按實際利率法以攤銷成本減任何減值列賬。

利息收入以實際利率確認，惟所確認利息可能極少的短期應收款項除外。

##### 金融資產減值

於各報告期間結算日，會評估金融資產(按公平值計入損益的金融資產除外)有否出現減值跡象。倘有客觀證據顯示，金融資產的估計未來現金流量因金融資產初步確認後發生的一項或多項事件而受到影響，則金融資產出現減值。

減值的客觀證據可包括：

For certain categories of financial asset, such as trade receivables, assets that are assessed not to be impaired individually are, in addition, assessed for impairment on a collective basis. Objective evidence of impairment for a portfolio of receivables could include the Group's past experience of collecting payments, an increase in the number of delayed payments in the portfolio past the credit period, observable changes in national or local economic conditions that correlate with default on receivables.

For financial assets carried at amortised cost, the amount of the impairment loss recognised is the difference between the asset's carrying amount and the present value of the estimated future cash flows, discounted at the financial asset's original effective interest rate.

The carrying amount of the financial asset is reduced by the impairment loss directly for all financial assets with the exception of trade receivables, where the carrying amount is reduced through the use of an allowance account. When a trade receivable is considered uncollectible, it is written off against the allowance account. Subsequent recoveries of amounts previously written off are credited against the allowance account. Changes in the carrying amount of the allowance account are recognised in profit or loss.

For financial assets measured at amortised cost, if, in a subsequent period, the amount of impairment loss decreases and the decrease can be related objectively to an event occurring after the impairment losses was recognised, the previously recognised impairment loss is reversed through profit or loss to the extent that the carrying amount of the asset at the date the impairment is reversed does not exceed what the amortised cost would have been had the impairment not been recognised.

##### 金融資產減值 (續)

就若干種類的金融資產而言(如貿易應收款項),經評估並無個別減值的資產其後會再次整體評估有否減值。應收款項組合減值的客觀證據可包括本集團的過往收款經驗,組合內超過信貸期仍未付款的款項增加以及全國或地方經濟狀況出現與拖欠應收款項有關的明顯變化。

就按攤銷成本入賬的金融資產而言,已確認減值虧損金額為資產賬面值與按金融資產原實際利率貼現的估計未來現金流量現值之間的差額。

就所有金融資產而言,金融資產的賬面值直接按減值虧損扣減,惟貿易應收款項的賬面值乃透過使用撥備賬扣減。倘貿易應收款項被認為不可收回,則於撥備賬撇銷。其後收回的過往撇銷款項計入撥備賬內。撥備賬的賬面值變動於損益表確認。

就按攤銷成本計量的金融資產而言,倘於往後期間,減值虧損金額減少,而該減少可客觀地與確認減值虧損後發生的事件有關,則先前確認的減值虧損會透過損益表撥回,惟該資產於撥回減值日期的賬面值不得超過在並無確認減值情況下應有的攤銷成本。

#### Financial liabilities and equity instruments

Debt and equity instruments issued by a group entity are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument.

#### Equity instruments

An equity instrument is any contract that evidences a residual interest in the assets of the Group after deducting all of its liabilities. Equity instruments issued by the Group are recognised at the proceeds received, net of direct issue costs.

#### Effective interest method

The effective interest method is a method of calculating the amortised cost of a debt instrument and of allocating interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premium or discounts) through the expected life of the financial liability, or, where appropriate, a shorter period to the net carrying amount on initial recognition.

Interest expense is recognised on an effective interest basis other than those financial liabilities designated as at financial liabilities at fair value through profit or loss.

#### Other financial liabilities

Other financial liabilities (including trade payables, accruals, deposits received and other payables, obligations under finance leases and bank borrowing) are subsequently measured at amortised cost, using the effective interest method.

集團實體發行的債務及權益工具按所訂立合約安排內容以及金融負債與權益工具的定義分類。

#### 權益工具

權益工具為證明本集團資產扣除全部負債後剩餘權益的任何合約。本集團發行的權益工具按已收所得款項扣除直接發行成本確認。

#### 實際利率法

實際利率法為計算債務工具攤銷成本及按有關期間分配利息開支的方法。實際利率為將估計日後現金付款(包括已付或已收構成實際利率組成部分的所有費用及點子、交易成本及其他溢價或折讓)按金融負債的預期使用年期或較短期間(倘適用)實際貼現至初步確認時賬面淨值的利率。

利息開支按實際利率基準(不包括指定為按公平值計入損益的金融負債)確認。

#### 其他金融負債

其他金融負債(包括貿易應付款項、應計費用、已收按金及其他應付款項、融資租賃承擔及銀行借款)其後以實際利率法按攤銷成本計量。

##### Derecognition

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. If the Group neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Group continues to recognise the asset to the extent of its continuing involvement and recognises an associated liability. If the Group retains substantially all the risks and rewards of ownership of a transferred financial asset, the Group continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.

On derecognition of a financial asset in its entirety, the difference between the asset's carrying amount and the sum of the consideration received and receivable and the cumulative gain or loss that had been recognised in other comprehensive income and accumulated in equity is recognised in profit or loss.

On derecognition of a financial asset other than in its entirety, the Group allocates the previous carrying amount of the financial asset between the part it continues to recognise, and the part it no longer recognises on the basis of the relative fair values of those parts on the date of the transfer. The difference between the carrying amount allocated to the part that is no longer recognised and the sum of the consideration received for the part no longer recognised and any cumulative gain or loss allocated to it that had been recognised in other comprehensive income is recognised in profit or loss. A cumulative gain or loss that had been recognised in other comprehensive income is allocated between the part that continues to be recognised and the part that is no longer recognised on the basis of the relative fair values of those parts.

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in profit or loss.

本集團僅會在自資產收取現金流量的合約權利屆滿，或其轉讓金融資產而資產所有權的絕大部分風險及回報轉移至另一實體時終止確認金融資產。倘本集團既無轉讓亦無保留所有權的絕大部分風險及回報而繼續控制已轉讓資產，則本集團會繼續確認資產，惟以其持續參與者為限，並確認相關負債。倘本集團保留已轉讓金融資產所有權的絕大部分風險及回報，則本集團繼續確認金融資產，亦會確認已收所得款項的有抵押借款。

於全面終止確認金融資產時，該資產賬面值與已收及應收代價總額及已於其他全面收益確認並於權益累積的累計收益或虧損之間的差額於損益表確認。

於終止確認金融資產 (並非全部) 時，本集團會將金融資產的過往賬面值按繼續確認部分與不再確認部分於轉讓日期的相對公平值在兩者之間作出分配。分配至不再確認部分的賬面值與不再確認部分的已收代價及其獲分配已於其他全面收益確認的任何累計收益或虧損的總額的差額於損益表確認。已於其他全面收益確認的累計收益或虧損，將按繼續確認部分及不再確認部分的相對公平值在兩者之間作出分配。

### Retirement benefits costs

The Group's contribution to the defined contribution retirement benefit plans are charged to consolidated statement of profit or loss and other comprehensive income in the year incurred and are reduced by contributions forfeited by those employees who leave the scheme prior to vesting fully in the contributions. The Group has no further payment obligations once the contributions have been paid.

### Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable and represents amounts receivable for services provided in the normal course of business, net of discount.

The Group recognises revenue when the amount of revenue can be reliably measured, it is probable that future economic benefits will flow to the entity and specific criteria have been met for each of the Group's activities as described below.

For service contract relates to routine cleaning services, the service income will be recognised on a straight-line basis over the contract terms as the work is performed.

For services that are provided on ad-hoc basis, service income is recognised upon completion of the provision of such ad-hoc services.

Interest income from a financial asset is accrued on a time basis by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts the estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount.

### 退休福利成本

本集團對定額供款退休福利計劃作出的供款於產生年度自綜合損益及其他全面收益表中扣除，並扣減僱員於供款悉數歸屬前退出計劃所沒收的供款。繳付供款後，本集團再無進一步付款責任。

### 收益確認

就有關日常清潔服務的服務合約而言，服務收入將按直線法於進行工作的合約期間確認。

就按特別基準提供的服務而言，服務收入於完成提供該特別服務後確認。

來自金融資產的利息收入按時間累計，並參考未償還的本金以適用實際利率計算。實際利率為按金融資產預期年期實際貼現估計未來現金收入至該資產賬面淨值的利率。

#### Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxation profit differs from profit as reported in consolidated statements of profit or loss and other comprehensive income because it excludes items of income or expense that are taxable or deductible in other years, and it further excludes items that are never taxable and deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amount of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences, and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the tax profit nor the accounting profit.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax is calculated at the tax rates that are expected to apply in the year when the liability is settled or the asset is realised. Current or deferred tax is charged or credited to consolidated statement of profit or loss and other comprehensive income, except when it relates to items that are recognised in other comprehensive income or directly to equity, in which case, the current and deferred tax is also recognised in other comprehensive income or directly in equity respectively. Where current tax or deferred tax arise from the initial accounting for a business combination, the tax effect is included in the accounting for the business combination.

所得稅開支指即期應付稅項與遞延稅項的總和。

即期應付稅項根據年度應課稅溢利計算。應課稅溢利與綜合損益及其他全面收益表呈報的溢利不同，原因為其不包括其他年度的應課稅或可扣減收入或開支項目，亦不包括毋須課稅或不可扣減項目。本集團的即期稅項負債採用於各報告期間結算日已實施或實質實施的稅率計算。

遞延稅項按財務報表內資產及負債的賬面值與計算應課稅溢利所採用的相應稅基之間的暫時性差額確認。所有應課稅的暫時性差額一般確認為遞延稅項負債。遞延稅項資產於應課稅溢利可能與可動用可扣減暫時性差額抵銷時確認。倘暫時性差額因商譽或在既不影響稅項溢利亦不影響會計溢利的交易(業務合併除外)中初步確認其他資產及負債而產生，則不會確認該等遞延稅項資產及負債。

遞延稅項資產賬面值於各報告期間結算日檢討，並作出扣減，惟以不再可能有足夠應課稅溢利以收回全部或部分資產為限。

遞延稅項按預期適用於清償負債或變現資產年度的稅率計算。即期或遞延稅項會扣自或計入綜合損益及其他全面收益表，惟倘其與於其他全面收益或直接於權益確認的項目有關的情況則除外，於該情況下，即期及遞延稅項亦分別於其他全面收益或直接於權益確認。倘即期稅項或遞延稅項產生自一項業務合併的初步會計，則有關稅務影響計入該業務合併的會計。

Deferred tax assets and liabilities are offset when they relate to income taxes levied by the same taxation authority and the entity intends to settle its current tax assets and liabilities on a net basis.

### Dividends

Dividend distribution to the Company's shareholders is recognised as a liability in the Group's and the Company's financial statements in the period in which the dividends are approved by the Company's shareholders or directors, where appropriate.

### Segment information

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the directors of the Group.

### Related parties

A party is considered to be related to the Group if:

- (i) A person, or close member of that person's family, is related to the Group if that person:
  - (1) has control or joint control over the Group;
  - (2) has significant influence over the Group; or
  - (3) is a member of the key management personnel of the Group or the Group's parent.

In the application of the Group's accounting policies, which are described in Note 3, management is required to make judgments, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revision to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

### Key sources of estimation uncertainty

The followings are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period that have a significant risk of causing material adjustment to the carrying amounts of assets and liabilities within the next financial year.

### Useful lives of property, plant and equipment

Management of the Group determines the estimated useful lives and related depreciation charges for the Group's plant and equipment. Management of the Group will revise the depreciation charges where useful lives are different to previously estimated, or it will write off or write down technically obsolete or non-strategic assets that have been abandoned or sold.

### Key sources of estimation uncertainty (continued)

#### Impairment loss in respect of trade receivables

The policy for impairment loss on trade receivables of the Group is based on the evaluation of collectability and ageing analysis of accounts and on management's judgment. A considerable amount of judgment is required in assessing the ultimate realisation of these receivables, including the current creditworthiness and the past collection history of each customer. If the financial conditions of customers of the Group were to deteriorate, resulting in an impairment of their ability to make payments, additional impairment loss may be required.

#### Provision

When there is a probability that an outflow of economic benefits will occur due to a present obligation resulting from a past event, and such amount can be reasonably estimated, a corresponding amount of provision is recognised in the consolidated financial statements. However, no provision is recognised for costs that need to be incurred to operate in the future.

#### Income taxes

The Group is subject to income taxes in Hong Kong. Significant judgment is required in determining provision for taxes. There are many transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. The Group recognises liabilities for anticipated tax audit issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax provisions in the year in which such determination is made.

#### 貿易應收款項的減值虧損

本集團貿易應收款項的減值虧損政策乃根據收款評估及賬齡分析按管理層判斷制定。評估該等應收款項的最終變現時，須作出大量判斷，包括各客戶的目前信譽及過往收款紀錄。倘本集團客戶的財政狀況惡化，導致其還款能力降低，則可能須作額外減值虧損。

#### 撥備

#### 所得稅

### (b) Financial risk management objectives and policies

The Group's activities expose it to a variety of financial risks: market risk (including foreign currency risk and interest rate risk), credit risk and liquidity risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

#### Market risk

##### (i) Foreign currency risk

The Group and the Company operate in Hong Kong only and is exposed to foreign exchange risk arising from Renminbi ("RMB") as certain bank balance of the Group is denominated in RMB. The Group's and the Company's management do not expect the net foreign currency risk from these activities to be significant and hence, the Group and the Company do not presently hedge the foreign exchange risks. The Group and the Company periodically review liquid assets and liabilities held in currencies other than HK\$ to evaluate its foreign exchange risk exposure.

本集團的業務令本集團面對多種財務風險：市場風險(包括外幣風險及利率風險)、信貸風險及流動資金風險。本集團的整體風險管理計劃集中於金融市場的不可預測性，旨在將對本集團財務表現的潛在不利影響降至最低。

#### 市場風險

##### (i) 外幣風險

#### Market risk (continued)

##### (ii) Interest rate risk management

The Group's cash flow interest rate risk relates primarily to variable-rate bank borrowings. It is the Group's policy to keep its borrowings at floating rate of interests so as to minimise the fair value interest rate risk.

As at 30 June 2014 and 2013, the Group's cash flow interest rate risk is mainly concentrated on the fluctuation of Hong Kong Dollar Prime Lending Rate/Best Lending Rate arising from the Group's Hong Kong Dollar denominated bank borrowing. Since the Group does not expect any significant movement in these interest rates, the Group's exposure to interest rate risk is minimal. The exposures to the interest rate risk are monitored on an ongoing basis.

#### Credit risk

At the end of each reporting period, the Group's maximum exposure to credit risk which will cause a financial loss to the Group due to failure to discharge an obligation by the counterparties is arising from the carrying amount of the respective recognised financial assets as stated in the consolidated statements of financial position.

In order to minimise the credit risk, the management reviews the recoverable amount of each individual debt at the end of each reporting period to ensure that adequate impairment losses are made for irrecoverable amounts. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced. The Group's credit risk is primarily attributable to bank deposits, bank balances and trade and other receivables. Individual credit evaluations are performed on all customers and counterparties. These evaluations focus on the counterparty's financial position, past history of making payments and take into account information specific to the counterparty as well as pertaining to the economic environment in which the counterparty operates. Management has a credit policy in place and the exposures to these credit risks are monitored on an ongoing basis.

#### 市場風險(續)

##### (ii) 利率風險管理

本集團的現金流量利率風險主要與浮動利率銀行借款有關。本集團的政策為將借款按浮動利率計息以盡量減低公平值利率風險。

於二零一四年及二零一三年六月三十日，本集團的現金流量利率風險源自本集團以港元計值的銀行借款，並主要集中於港元最優惠貸款利率的波動。由於本集團預期利率不會有任何重大變動，本集團承受的利率風險微乎其微。利率風險按持續基準監控。

#### 信貸風險

於各報告期間結算日，本集團因對手方未能履行責任，而將導致本集團蒙受財務虧損的最高信貸風險，來自綜合財務狀況表所列有關已確認金融資產的賬面值。

為盡量減低信貸風險，管理層於各報告期間結算日檢討各個別債項的可收回金額，確保為不可收回金額計提充足減值虧損。就此而言，本公司董事認為本集團的信貸風險已大幅降低。本集團的信貸風險主要來自銀行存款、銀行結餘及貿易及其他應收款項。本集團會對所有客戶及對手方作出個別信貸評估。此等評估集中於對手方的財務狀況、付款記錄，並經考慮對手方的具體資料，以及有關對手方經營所在的經濟環境的資料。管理層已實施信貸政策，並會持續監控信貸風險。

#### Credit risk (continued)

The Group had certain concentration of credit risk as 71.3% and 62.0% of the total trade receivables of the Group were due from 5 customers as at 30 June 2014 and 2013 respectively. Management considered the credit risk is limited since the Group trades only with customers with an appropriate credit history and good reputation. The management monitored the financial background and creditability of those debtors on an ongoing basis. In addition, the credit risk on liquid funds including bank deposits and bank balances is limited because the counterparties are banks with good reputation.

#### Liquidity risk

The Group has to maintain a suitable level of liquidity to finance the daily operation, capital expenditure and repayment of borrowings. The Group's policy is to regularly monitor current and expected liquidity requirements and its compliance with lending covenants to ensure that it maintains sufficient reserves of cash to meet its liquidity requirements in the short and longer term.

Specifically, for secured term loans which contain a repayment on demand clause which can be exercised at the bank's sole discretion, the analysis shows the cash outflow based on the earliest period in which the entity can be required to pay, that is if the lenders were to invoke their unconditional rights to call the loans with immediate effect. The maturity analysis for other bank borrowings is prepared based on the scheduled repayment dates.

#### 信貸風險(續)

於二零一四年及二零一三年六月三十日，由於本集團應收五名客戶的款項分別佔總貿易應收款項的71.3%及62.0%，故本集團面對某程度上的集中信貸風險。由於本集團僅與擁有恰當信貸紀錄及良好信譽的客戶交易，故管理層認為信貸風險有限。管理層持續監控該等債務人的財務背景及可信性。此外，銀行存款及銀行結餘等流動資金的信貸風險有限，因為對手方為信譽良好的銀行。

#### 流動資金風險

本集團將維持適當水平的流動資金，以撥付日常業務運作、資本開支及償還借款所需資金。本集團的政策為定期監控即期及預期流動資金需要及有否遵守借款契諾，確保其維持充裕現金儲備，以應付短期及較長期的流動資金需要。

具體而言，對於含有按要求償還條款(由銀行全權酌情行使)的有抵押定期貸款而言，分析顯示在最早期間實體須償還的現金流出，即貸款人行使其無條件收回貸款的權利並即時生效時。其他銀行借款的到期日分析按照既定還款日期編製。

## 7. CAPITAL RISK MANAGEMENT

The Group's primary objectives when managing capital are to safeguard the Group's ability to continue as a going concern, so that it can continue to provide returns for shareholders of the Group and benefits for other stakeholders, by pricing products and services commensurately with the level of risk and by securing access to finance at a reasonable cost.

The Group actively and regularly reviews and manages its capital structure to maximise the returns to maintain a balance between the higher shareholder returns that might be possible with higher levels of borrowings and the advantages and security afforded by a sound capital position, and makes adjustments to the capital structure in light of changes in economic conditions.

Neither the Company nor any of its subsidiaries are subject to externally imposed capital requirements.

The capital structure of the Group mainly consists of debts, which include borrowings from banks and obligations under finance leases, and equity attributable to owners of the Group, comprising issued share capital, share premium, other reserve, contribution surplus and retained earnings. The Group considers the cost of capital and the risks associated with each class of capital to monitor its capital structure on the basis of a gearing ratio. This ratio is expressed by as a percentage of total borrowings over the total equity. The Group's overall strategy remains unchanged during the years ended 30 June 2014 and 2013.

## 29. RETIREMENT BENEFIT COSTS

### Defined contribution plan

The Group offers two retirement schemes which together cover all permanent staff.

The Group operates a Mandatory Provident Fund Scheme ("MPF Scheme") for all its qualifying employees in Hong Kong under the Mandatory Provident Fund Schemes Ordinance. The assets of the MPF Scheme are held separately from those of the Group in funds under the control of trustees. Under the rule of the MPF Scheme, the employer and its employees are each required to make contributions to the scheme at rates specified in the rules. The only obligation of the Group with respect of MPF Scheme is to make the required contributions under the MPF Scheme. No forfeited contribution is available to reduce the contribution payable in the future years.

The contribution to the MPF Scheme is calculated based on the rules set out in the MPF Ordinance which is 5% on the basic salary of the relevant employee subject to a specific ceiling of HK\$1,500 (HK\$1,250 prior to 1 June 2014).

Another scheme is defined contribution in nature and established under trust and is registered under the Hong Kong Occupational Retirement Schemes Ordinance. The assets of the schemes are held independently of the Group's assets in separate trustee administered funds.

The total expense recognised in the consolidated statement of profit or loss and other comprehensive income of approximately HK\$3,784,000 (2013: HK\$4,039,000) for the year ended 30 June 2014 represents contributions payable to these plans by the Group at rates specified in the rules of the plans.

## 29. 退休福利成本

## 31. SHARE OPTION SCHEME

The Company conditionally operates a share option scheme ("Share Option Scheme") for the purpose of attract, retain and reward the eligible persons and to provide the eligible persons an incentive or reward for their contribution to the Group and by enabling such persons' contribution to further advance the interests of the Group. The Share Option Scheme was adopted on 28 May 2013 and shall be valid and effective for a period of ten years commencing from the date of adoption, after which period no further options will be offered or granted but the provisions of the Share Option Scheme shall remain in full force and effect in all other respects with respect to options granted during the life of the Share Option Scheme.

The eligible persons of the Share Option Scheme include directors, consultants or advisers and any other person who has contributed to the Group (the "Eligible Persons").

The subscription price of the share options shall be a price determined by the board of directors and shall be at least the highest of (i) the closing price per share as stated in the Stock Exchange's daily quotation sheet on the offer date; (ii) the average of the closing prices per share as stated in the Stock Exchange's daily quotation sheets for the five business days immediately preceding the offer date; or (iii) the nominal value of the share.

The amount payable by the grantee to the Company on acceptance of the offer shall be a nominal amount to be determined by the board of directors.

The total number of shares which may be issued upon exercise of all options to be granted under the Share Option Scheme and any other Share Option Schemes shall not in aggregate exceed 10% of the total number of shares in issue as at the date of approval of the Share Option Scheme. The Company may grant options to specified participant(s) beyond the 10% limit provided that the options granted in excess of such limit are specifically approved by the shareholders in general meeting and the participants are specifically identified by the Company before such approval is sought. In seeking such approval, a circular must be sent to the shareholders containing the required details in accordance with Chapter 23 of the GEM Listing Rules.

The maximum number of shares in respect of which options may be granted under the Share Option Scheme together with any options outstanding and yet to be exercised under the Share Option Scheme and any other share option schemes of the Company in issue shall not exceed 30% (or such higher percentage as may be allowed under the GEM Listing Rules) of the total number of shares in issue from time to time.

The Company was informed by Viva Future, that on 25 July 2014, Viva Future entered into transfer documents for the disposal of in aggregate of 280,000,000 shares (the "Shares") in the capital of the Company held by it to five investors, namely Xin Hong, Zhao Han, Lai Junning, Fu Wenhui and Lin Shangquan (collectively the "Investors") as to 20,000,000, 130,000,000, 45,000,000, 45,000,000 and 40,000,000 Shares at HK\$16,400,000, HK\$87,100,000, HK\$34,650,000, HK\$32,400,000 and HK\$32,800,000 respectively. To the best knowledge, information and belief of the directors, the Investors are independent third parties not connected with the Company and its connected persons (as defined under the GEM Listing Rules) (such disposals shall be collectively referred to as the "Disposals"). Shares disposed via the Disposals represent in aggregate approximately 28% of the total issued share capital of the Company (the "Share Capital"). Following the Disposals, the total interests of Mr. Fan in the Shares including family and other interests within the meaning of Part XV of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) are 420,000,000 Shares, representing approximately 42% of the Share Capital, of which 225,000,000 Shares, representing approximately 22.5% of the Share Capital, had been charged as security (the "Charged Shares") in favour of Mr. Fong Shing Kwong, Michael ("Mr. Fong") for a facility granted to Viva Future.

On 4 August 2014, the Company received a notice from Mr. Fan that the Charged Shares have been released by Mr. Fong and the relevant registration procedures for the release of charge of the relevant Charged Shares have been completed.

Save as disclosed above, the Group had no significant events after the end of the reporting period.

## 37. COMPARATIVES

## 38. APPROVAL OF FINANCIAL STATEMENTS

The consolidated financial statements were approved and authorised for issue by the board of directors on 25 September 2014.
